RESOLUTION AUTHORIZING THE HON. MA. ESTER E. HAMOR, CITY MAYOR, SORSOGON CITY REPRESENTING THE CITY GOVERNMENT OF SORSOGON TO ENTER INTO A USUFRUCT AGREEMENT CONCERNING THE PROPERTY, A PARCEL OF LAND WITH A TOTAL LAND AREA OF THIRTEEN THOUSAND FIVE HUNDRED FIFTY TWO (13,552) SQUARE METERS LOCATED AT BARANGAY BALOGO, EAST DISTRICT, SORSOGON CITY WHERE BALOGO ELEMENTARY SCHOOL IS SITUATED IN FAVOR OF THE DEPARTMENT OF EDUCATION (DEPED) SORSOGON CITY

WHEREAS, among the items deliberated during the November 22, 2022 Regular Session of the 8th City Council was the manifestation of the Hon. Nestor J. Baldon relative to the City Government Property located at Brgy. Balogo, East District, Sorsogon City;

WHEREAS, it is but right and proper to execute a usufruct agreement by and between the City Government of Sorsogon and the Department of Education (DepEd) Sorsogon City for the use of the said lot in favor of Balogo Elementary School;

WHEREAS, every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom; as well as powers necessary, appropriate or incidental for its efficient and effective governance and those which are essential to the promotion of the general welfare. Within their respective territorial jurisdiction, local government units shall ensure and support, among other things, the preservation and enrichment of culture, promote health and safety, improve public morals, enhance economic prosperity and social justice, maintain peace and order and preserve the comfort and convenience of their inhabitants;

WHEREAS, premises considered to avoid any future legal questions concerning the said transfer, the City Government of Sorsogon hereby expressed its intention to transfer its use and possession to Balogo Elementary School and to the Department of Education (DEPED) Sorsogon City;

WHEREAS, in consonance thereto, the authority of the City Mayor to enter into a usufruct agreement with the Balogo Elementary School and the Department of Education (DEPED) Sorsogon City is hereby issued for the purpose;

NOW THEREFORE, on incidental motion of **Hon. Nestor J. Baldon** duly seconded by **Hon. Jo Abegail C. Dioneda**, resolve as it is hereby resolved to authorize the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City representing the City Government of Sorsogon to enter into a Usufruct Agreement concerning the property, a parcel of land with a total land area of thirteen thousand five hundred fifty two (13,552) square meters located at Barangay Balogo, East District, Sorsogon City where Balogo Elementary School is situated in favor of the Department of Education (DepEd) Sorsogon City.

RESOLVED FURTHER, that copies of this resolution be furnished to all concerned for their information and guidance.
