RESOLUTION DESIGNATING THE CITY GOVERNMENT BAKERIES AS TRAINING CENTERS FOR BREAD AND PASTRY PROGRAM, NATIONAL CERTIFICATE II (NC II) PROGRAM OF THE TECHNICAL EDUCATION AND SKILLS DEVELOPMENT AUTHORITY (TESDA).

WHEREAS, among the items deliberated during the November 22, 2022 Regular Session of the 8th City Council is Transmittal No. 83, Series of 2022 from the Office of the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City addressed to the Hon. Mark Eric C. Dioneda, City Vice Mayor and Honorable Members of the Sangguniang Panlungsod thru the SP Secretary dated November 11, 2022 requesting for the passage of a Resolution designating the City Government Bakeries as Training Centers for Bread and Pastry Program, National Certificate II (NC II) Program of the Technical Education and Skills Development Authority (TESDA);

WHEREAS, among the components of YES to Children Assistance Program (YCAP) is the establishment and operation of bakeries in three (3) districts of Sorsogon City thus, the primary purpose of said bakeries, is to provide the children with healthy bread for their snacks as part of the City Government of Sorsogon's efforts to ensure they eat healthy snacks;

WHEREAS, as an additional purpose and still within the ambit of providing quality education to Sorsogonans, the City Government of Sorsogon intends to use the bakeries as Training Centers for Bread and Pastry, National Certificate II (NC II) under the Technical Education and Skills Development Authority (TESDA);

WHEREAS, with this, the City of Sorsogon shall be able to provide Trainees with an area that is conducive for learning wherein there are available equipment to be used for their training thus boosting their aptitude and capability to learn;


NOW THEREFORE, on incidental motion of **Hon. Ma. Teresa D. Perdigon** duly seconded by **Hon. Jo Abegail C. Dioneda**, resolve as it is hereby resolved to designate the City Government Bakeries as Training Centers for Bread and Pastry Program, National Certificate II (NC II) Program of the Technical Education and Skills Development Authority (TESDA);
