## *Resolution No. 470, Series of 2022*

**RESOLUTION AUTHORIZING THE CONDUCT OF TRADITIONAL COCKFIGHTING ACTIVITIES SUCH AS ENCONTRADAS/2-COCK ULUTAN EVERY FRIDAY OF THE MONTH AT SORSOGON COCKPIT COLISEUM AND EVERY SATURDAY OF THE MONTH AT GUINLAJON COCKPIT COLISEUM AND SHALL BE RESERVED AND INTENDED FOR CHARITABLE INSTITUTIONS, CIVIL SOCIETY ORGANIZATIONS AND PEOPLE'S ORGANIZATIONS BY WHICH THEIR APPLICATION FOR THE CONDUCT OF THE SAME AS RECEIVED BY THE OFFICE OF THE SECRETARY TO THE SANGGUNIANG PANLUNGSOD SHALL DEEMED APPROVED WITHOUT NEED OF FURTHER LEGISLATION FOR THE PURPOSE**

**WHEREAS**, in order to deter illegal cockfighting activities, the 8<sup>th</sup> City Council, through a resolution authorizes the conduct of traditional cockfighting activities to be held at authorized cockfighting arenas;

**WHEREAS**, the authority for the conduct of traditional cockfighting activities is in consonance with the relevant national policies and as among the devolved functions of

local government units pursuant to Section 458 (3) (v) of Republic Act 7160 otherwise known as the Local Government Code of 1991;

**WHEREAS**, Section 7 of City Ordinance No. 10, Series of 2020, otherwise known as the “Sorsogon City Cockfighting Code of 2020” provides that organizations intending to have charity works and Barangay Governments intending to raise funds for their various governmental programs, projects and activities not included in their respective annual and supplemental budgets may apply to the Sangguniang Panlungsod to hold cockfights in the above mentioned authorized cockpits at such certain day or days at least one (1) month prior to the holding thereof;

**WHEREAS**, application of for the conduct of traditional cockfighting activities, the corresponding permit and the official receipt issued by the Office of the Treasurer as proof of payment thereof, and this resolution shall be in the possession of the owner of the concerned cockpit during the said activity;

**WHEREAS**, this measure has its objective to promptly act on the application/s to conduct traditional cockfighting activities by the charitable institutions, civil society organizations and people’s organizations so as not to hamper its approval due to circumstances outside the control of the Sangguniang Panlungsod;

**WHEREAS**, foregoing premises considered and after due deliberation on the matter, the 8<sup>th</sup> City Council deemed it necessary to pass a resolution authorizing the conduct of traditional cockfighting activities such as encontradas/2-cock ulutan every Friday of the month at Sorsogon Cockpit Coliseum and every Saturday of the month at Guinlajon Cockpit Coliseum and shall be reserved and intended for charitable institutions, civil society organizations and people’s organizations by which their application for the conduct of the same as received by the Office of the Secretary to the Sangguniang Panlungsod shall deemed approved without need of further legislation for the purpose;

**NOW THEREFORE**, on motion of the **Hon. Nestor J. Baldon** duly seconded by **Hon. Glenn P. Olbes**, resolve as it is hereby resolved to authorize the conduct of traditional cockfighting activities such as encontradas/2-cock ulutan every Friday of the month at Sorsogon Cockpit Coliseum and every Saturday of the month at Guinlajon Cockpit Coliseum and shall be reserved and intended for charitable institutions, civil society organizations and people’s organizations by which their application for the conduct of the same as received by the Office of the Secretary to the Sangguniang Panlungsod shall deemed approved without need of further legislation for the purpose.

**RESOLVED FURTHER**, that copies of this resolution be furnished to all concerned for their information and guidance.
