

in the areas of formal and non-formal basic education; supervise all elementary and secondary education institutions, including alternative learning systems, both public and private; and provide for the establishment and maintenance of a complete, adequate and integrated system of basic education relevant to the goals of the national development;

WHEREAS, DepEd has introduced the K to 12 basic education reform program that includes Senior High School with the major objective of ensuring that graduates of basic education are ready for employment, entrepreneurship and higher learning hence SHS curriculum can be customized at the local levels to take into consideration the needs of local industries and the labor market;

WHEREAS, DepEd believes that for the effective delivery of SHS instruction, there is a need for school industry partnership that will provide the school the necessary expertise and venue for practical, on-the-job, enterprise-based training for SHS learners;

WHEREAS, to achieve the DepEd's objectives for SHS, the school needs to enter into a Work Immersion Partnership with the LGU thus the LGU operates in the area where the school is located and has office, facilities, project sites and expertise that it can make available to the school for purposes of student Work Immersion;

WHEREAS, the LGU considers going into a Work Immersion Partnership with the School as part of its mission to create a positive impact on the community, especially the young people hence the institutionalization and implementation of the K to 12 program is among the priority programs of the government for producing inclusive growth;

WHEREAS, the LGU is encouraged to fully support the successful implementation of the K to 12 program of the Department of Education as stated in Paragraph 4, Section 2 of the Republic Act 9155 or "Governance of Basic Education Act of 2002";

WHEREAS, attached to the transmittal is a copy of a draft Memorandum of Agreement for Work Immersion Partnership for further perusal of the 8th City Council;

NOW THEREFORE, on incidental motion of the **Hon. Jo Abegail C. Dioneda**, duly seconded by the **Hon. Renalene Mae J. Duka** resolve as it is hereby resolved to authorize the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City to enter into a Memorandum of Agreement (MOA) for Work Immersion Partnership by and between the City Government of Sorsogon and Capul Agro-Industrial Industrial School Senior High School Department represented by its School Head, Mr. Ryan D. Catucod relative to the Work Immersion/On-the-Job Partnership as part of the K to 12 Curriculum;
