**RESOLUTION DECLARING VALID BARANGAY RESOLUTION NO. 036-2022, ORDINANCE NO. 001-2022 OF BARANGAY BALOGO, EAST DISTRICT, SORSOGON CITY ENTITLED, "AN ORDINANCE PROVIDING THE USE OF WHEEL CLAMPS TO IMMOBILIZE ILLEGALLY PARKED VEHICLES, IMPOSING PENALTIES FOR VIOLATIONS THEREOF AND FOR OTHER PURPOSES OF BARANGAY BALOGO, EAST DISTRICT, SORSOGON CITY**

**WHEREAS**, among the items deliberated during the December 6, 2022 Regular Session of the 8<sup>th</sup> City Council was the Committee Report No. 064, Series of 2022 of the Committee on Rules relative to the Barangay Ordinance No. 001-2022 entitled "An Ordinance Providing the Use of Wheel Clamps to Immobilize Illegally Parked Vehicles, Imposing Penalties for Violations thereof and for other purposes of Barangay Balogo, East District, Sorsogon City;

**WHEREAS**, such legislative measure aim to curb and reduce traffic congestion in the national highway from Sorsogon National High School through the junction at Mahingan and the busy streets of the Barangay Balogo;

**WHEREAS**, one of the recommendations of Atty. Cyril C. Oropesa, City Legal Officer, relative to the imposition of the wheel clamp ordinance shall be within the specified period of time inclusive of the towing after the lapse of three hours at the impounding area and the corresponding penalty thereof shall be graduated and in accordance with the provisions of RA 7160;

**WHEREAS**, foregoing premises considered and after due deliberation on the matter, the 8<sup>th</sup> City Council deemed it necessary to pass a resolution declaring valid Barangay Resolution No. 036-2022, Ordinance No. 001-2022 of Barangay Balogo, East District, Sorsogon City entitled, "An Ordinance Providing the Use of Wheel Clamps to Immobilize Illegally Parked Vehicles, Imposing Penalties for Violations Thereof and for Other Purposes of Barangay Balogo, East District, Sorsogon City;
