RESOLUTION AUTHORIZING THE HON. MA. ESTER E. HAMOR, CITY MAYOR, SORSOGON CITY, TO ENTER INTO A MEMORANDUM OF UNDERSTANDING (MOU) WITH THE LEWIS COLLEGE (TLC) REPRESENTED BY MR. FRANCISCO NICOLO NICOLAS III, EXECUTIVE VICE PRESIDENT, FOR THE DEVELOPMENT AND OPERATION OF A SOFTWARE INTENDED FOR THE MONITORING OF THE PROCUREMENT PROCESS AND THE INVENTORY OF LGU PROPERTIES AND EQUIPMENT.

WHEREAS, among the items deliberated during the December 13, 2022 Regular Session of the 8th City Council is Transmittal No. 92, Series of 2022 from the Office of the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City addressed to the Hon. Mark Eric C. Dioneda, City Vice Mayor and Honorable Members of the Sangguniang Panlungsod thru the SP Secretary dated December 9, 2022 requesting for the passage of a Resolution authorizing the Local Chief Executive to enter into a Memorandum of Understanding (MOU) with the Lewis College represented by Mr.

Francisco Nicolo Nocolas III, Executive Vice President for the development and operation of a software intended for the monitoring of the procurement process and the inventory of LGU properties and equipment;

WHEREAS, the development of the software intends to facilitate the expeditious processing and recording of the procurement process as well as ensure that the property, plant and equipment of the LGU is efficiently implemented;

WHEREAS, the Lewis College, after due deliberation, has agreed to forge a partnership with the City Government as the said educational institution has the personnel who can deliver the needed software thus, to formally commence with the project, the parties agreed to enter into an arrangement thru a Memorandum of Understanding (MOU);

WHEREAS, attached to the transmittal is a copy of a draft Memorandum of Understanding (MOU) for further perusal of the 8th City Council;

NOW THEREFORE, on incidental motion of **Hon. Mark Jayson D. Jamisola** duly seconded by **Hon. Jo Abegail C. Dioneda** resolve as it is hereby resolved to authorize the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City to enter into a Memorandum of Understanding (MOU) with the Lewis College represented by Mr. Francisco Nicolo Nocolas III, Executive Vice President for the development and operation of a software intended for the monitoring of the procurement process and the inventory of LGU properties and equipment;
