RESOLUTION AUTHORIZING THE UTILIZATION OF BALANCES FROM OTHER INFRASTRUCTURE ASSETS OF THE CITY ENGINEERING OFFICE TO COVER VARIATION ORDERS UNDER SPECIFIC PROGRAMS, PROJECTS AND ACTIVITIES OF CITY MAYOR'S OFFICE-PROGRAMS, PROJECTS AND ACTIVITIES (CMO-PPA'S).

WHEREAS, on December 19, 2022, Engr. Roel R. Domer, City Engineer wrote a letter request addressed to Mrs. Jinky Aquino, City Budget Officer respectfully requesting for funds amounting to Four Hundred Ninety Five Thousand Seven Hundred Fifty Four 37/100 chargeable against the Other Infrastructure Assets of the City Engineering Office to cover variation order for Specific Programs, Projects and Activities of City Mayor's Office-Programs, Projects and Activities (CMO-PPA's);

WHEREAS, in response thereof, a covering reversion of funds reflected under Supplemental Budget No. 06, series of 2022 pursuant to existing budgeting and accounting rules and regulations of local government units;

WHEREAS, foregoing premise considered, the 8th City Council deemed it necessary to authorize the utilization of balances from Other Infrastructure Assets of the City Engineering Office to cover variation orders under specific Programs, Projects and Activities of City Mayor's Office-Programs, Projects and Activities (CMO-PPA's);
