## CONTRACT AGREEMENT

Contract No. 2202-2022 SVP

THIS AGREEMENT made this **28th** day of **October**, **2022** between **Ma. Ester E. Hamor**, City Mayor, City of Sorsogon Philippines ( hereinafter called the " Entity" ) of the one part and **JUDE A. TUMALAD** proprietor of **JAD MARKETING** ( hereinafter called the "Supplier" ) of the other part:

WHEREAS the Entity invited Bids for certain goods and ancillary services, viz **SUPPLY AND DELIVERY OF VARIOUS SUPPLIES AND EQUIPMENT FOR VENUE DECORATION, CUSTOMIZED TOKEN, HOUSEWARMING AND PROSPERITY SUPPLIES FOR THE TURNOVER OF HOUSING UNIT AT BON-OT, BACON DIST** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum **Two Hundred Seventy Eight Thousand Eight Hundred Pesos ( ₱ 278,800.00 ) Only** ( hereinafter called "the Contract Price" ).

- ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- iii. Performance Security;
- iv. Notice of Award of Contract; and the Bidder's conforme thereto; and

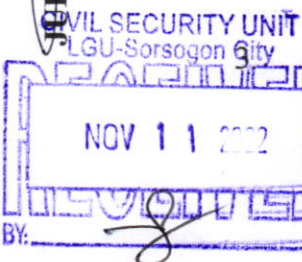
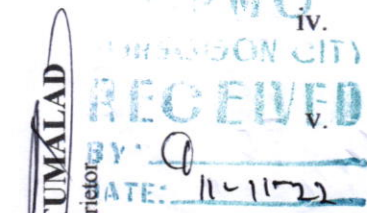
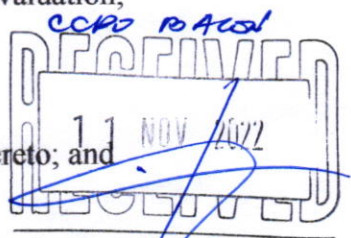
