## **CONTRACT AGREEMENT**

THIS AGREEMENT made this 18th day of November , 2022 between Ma. Ester E. Hamor , City Mayor, City of Sorsogon Philippines ( hereinafter called the "Entity" ) of the one part and JOEFFREY A. PERALTA Branch Manager of K-SERVICO TRADE, INC. (hereinafter called the "Supplier" ) of the other part:
