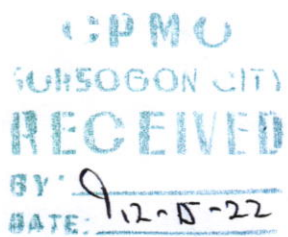
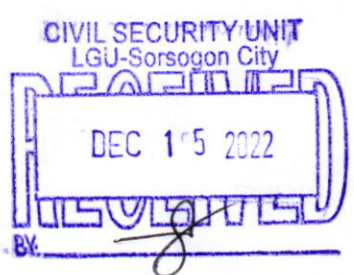

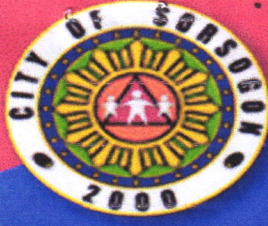

## CONTRACT AGREEMENT

Contract No. 2576 -2022 SVP

THIS AGREEMENT made this 2<sup>nd</sup> day of **December**, 2022 between **Ma. Ester E. Hamor**, City Mayor, City of Sorsogon Philippines ( hereinafter called the " Entity" ) of the one part and **JOHN ROBERT D. ECHANO** proprietor of **JEG & JOE ENTERPRISES CO.** ( hereinafter called the "Supplier" ) of the other part:

WHEREAS the Entity invited Bids for certain goods and ancillary services, viz **SUPPLY AND DIFF FISHNG GEARS AND FISHERY IMPLEMENTS FOR IVELIHOOD PROGRAM** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum **Seven Hundred Ninety Four Thousand One Hundred Twenty Six Pesos ( ₱ 794,126.00 ) Only** (hereinafter called "the Contract Price").

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- iii. Performance Security;
- iv. Notice of Award of Contract; and the Bidder's conforme thereto; and

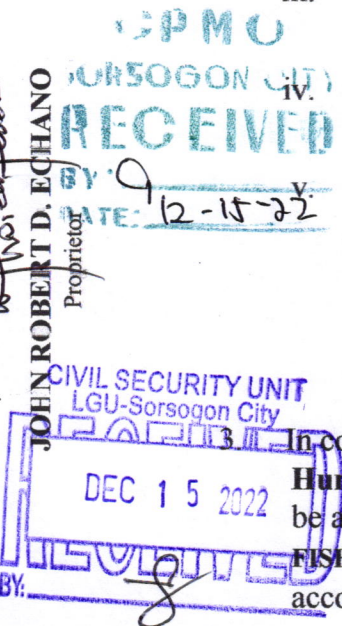
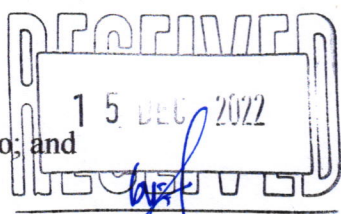
