### CONTRACT AGREEMENT

Contract No. 2518 -2022 SVP

THIS AGREEMENT made this 12<sup>th</sup> day of **December**, 2022 between **Ma. Ester E. Hamor**, City Mayor, City of Sorsogon Philippines ( hereinafter called the " Entity" ) of the one part and **FATIMA E. LEE** proprietor of **F.E.LEE SPORTS BAR AND RESTAURANT** ( hereinafter called the "Supplier" ) of the other part:

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- iii. Performance Security;
- iv. Notice of Award of Contract; and the Bidder's conforme thereto, and

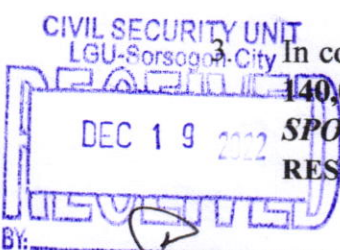
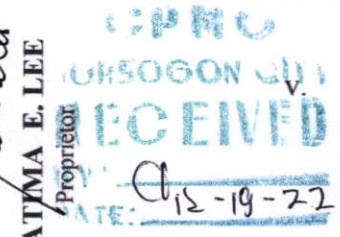
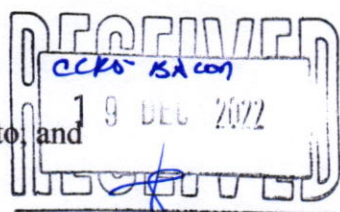

4. The City Government of Sorsogon agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.





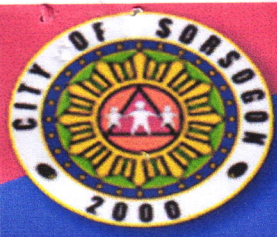
