CONTRACT AGREEMENT

THIS AGREEMENT made this **10th** day of **February**, **2023** between **Ma. Ester E. Hamor**, **City Mayor, City of Sorsogon** Philippines (hereinafter called the " Entity") of the one part and **MIKAELA MAE ESPEDIDO** Proprietor of **KYLA CONSTRUCTION SUPPLY** (hereinafter called the "Supplier") of the other part:

WHEREAS the Entity invited Bids for certain goods and ancillary services, viz **SUPPLY & DELIVERY OF MATERIALS FOR THE REPAIR OF MPB (MAIN RHU-EAST)** and has accepted a Bid by the Supplier for the supply of those goods and services in the **Two Hundred Fifty One Thousand Eight Hundred Ten Pesos (P251,810.00)** (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

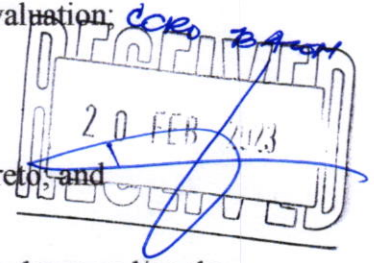
1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- iii. Performance Security;
- iv. Notice of Award of Contract; and the Bidder's conforme thereto; and

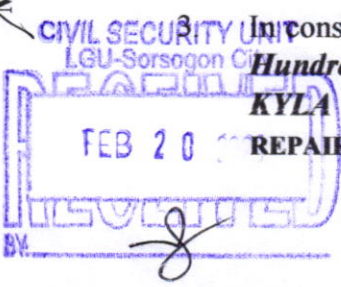
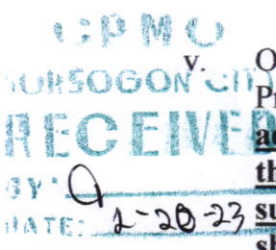
