CONTRACT AGREEMENT

THIS AGREEMENT made this 16th day of July , 2020 between Ma. Ester E. Hamor, City Mayor, City of Sorsogon Philippines (hereinafter called the "Entity") of the one part and JOCELYN C. ESTEVES Authorized Signatory of PACIFICA AGRIVET SUPPLIES, INC. (hereinafter called the "Supplier") of the other part:

WHEREAS the Entity invited Bids for certain goods and ancillary services, viz SUPPLY AND DELIVERY OF ANTI-RABBIES VACCINE FOR CITY VET OFFICE and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of Seven Hundred Seventy Nine Thousand Nine Hundred Seventy Four Pesos (P 779,974.00 (hereinafter called "the Contract Price").

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (*e.g.*, Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. <u>Winning bidder agrees that</u> additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

In consideration for the sum of Seven Hundred Seventy Nine Thousand Nine Hundred Seventy Four Pesos (P 779,974.00 or such other sums as may be ascertained, PACIFICA AGRIVET SUPPLIES, INC. agrees to viz SUPPLY AND DELIVERY OF ANTI-RABBIES VACCINE FOR CITY VET OFFICE in accordance with his/her/its Bid.





The City Government of Sorsogon agrees to pay the above-mentioned sum in 4. accordance with the terms of the Bidding.
