RESOLUTION DECLARING VALID BARANGAY ORDINANCE NO. 015, SERIES OF 2022 OF THE BARANGAY COUNCIL OF ALMENDRAS COGON, EAST DISTRICT, SORSOGON CITY ENTITLED “RESOLUTION TO AMEND THE TAX CODE OF BARANGAY ALMENDRAS- COGON, EAST DISTRICT, SORSOGON CITY TO HELP BUILD A STRONGER AND SELF- RELIANT GOVERNANCE”

WHEREAS, Committee Report No. 002, Series of 2023 of the Committee on Rules and Internal Affairs, entitled “Resolution to amend the tax code of Barangay Almendras- Cogon, East District, Sorsogon City to help build a stronger and self- reliant governance was among the items deliberated upon by the 8th City Council during the January 10, 2023 Regular Session;

WHEREAS, cursory reading of the submitted barangay ordinance reveals that the said barangay ordinance is within the ambits of the powers conferred to the barangay council by virtue of Chapter 4, Section 391 of Republic Act 7160 otherwise known as the Local Government Code of 1991.

WHEREAS, the Sangguniang Panlungsod finds the barangay ordinance intra vires as mandated by the Local Government Code of 1991;

WHEREAS, foregoing premise considered and after due deliberation on the matter, the 8th City Council deemed it necessary to pass a resolution declaring valid Barangay Ordinance No. 015, Series Of 2022 from the Barangay Council of Barangay Almendras-Cogon, East District, Sorsogon City entitled “Resolution to amend the tax code of Barangay Almendras- Cogon, East District, Sorsogon City to help build a stronger and self- reliant governance;
