RESOLUTION APPROVING AND AUTHORIZING THE CONDUCT OF TWO (2) COCK DERBY SPONSORED BY ARTUTO GABRIEL JR. ON JANUARY 28, 2023 AT GUINLAJON COCKPIT COLISEUM, BARANGAY GUINLAJON, WEST DISTRICT, SORSOGON CITY FOR THE BENEFIT OF SENIOR CITIZENS OF BRGY. BULABOG, WEST DISTRICT, SORSOGON CITY

WHEREAS, among the items deliberated during the January 10, 2023 Regular Session of the 8th City Council was the letter from Mr. Arturo Gabriel Jr., Promoter addressed to Hon. Nestor J. Baldon, City Councilor, Sorsogon City dated January 3, 2023 relative to the request for a conduct of two (2) cock derby on January 28, 2023 at Guinlajon Cockpit Coliseum, Brgy. Guinlajon, West District, Sorsogon City;

WHEREAS, as per consensus, a certain amount of the total share of the requesting party from the derby shall be reserved and retained by the Committee on Games and Amusement through the owner of the cockpit and shall be given to the respective charitable institution (**SENIOR CITIZENS OF BRGY. BULABOG, WEST DISTRICT, SORSOGON CITY**) and that the party shall faithfully comply therewith;

WHEREAS, pursuant to Inter Agency Task Force on Covid19 (IATF) Resolution No. 154, Series of 2021 and to the existing laws and regulations and as provided by Republic Act 7160 otherwise known as the Local Government Code of 1991, the Sangguniang Panlungsod has the power to regulate the conduct of cockfighting within the territorial jurisdiction of the City;

WHEREAS, foregoing premises considered and after due deliberation on the matter, the 8th City Council deemed it necessary to pass a resolution approving and authorizing the conduct of two (2) cock derby on January 28, 2023 at Guinlajon Cockpit Coliseum, Brgy. Guinlajon, West District, Sorsogon City;

NOW THEREFORE, on incidental motion of **Hon. Nestor J. Baldon**, duly seconded by **Hon. Peter Joseph J. Ravanilla**, resolved as it is hereby resolve to approve and authorize the conduct of two (2) cock derby on January 28, 2023 at Guinlajon Cockpit Coliseum, Barangay Guinlajon, West District, Sorsogon City;

RESOLVED FURTHER, that fees and charges appurtenant thereto shall be paid to the City Treasurer's Office prior to the conduct of the activity;

RESOLVED FINALLY, that copies of this resolution be furnished to all concerned for their information and guidance.
