HAMOR THRU THE CITY ENGINEER'S OFFICE IN CLOSE COORDINATION WITH DPWH 1ST ENGINEERING DISTRICT TO EFFECT IMMEDIATE ACTION ON THE FLOODING AT CORNER MAHINGAN AND BARANGAY ROAD AT BARANGAY BALOGO AND THE ROAD AT THE PERIMETER OF DUKA ENTERPRISES GOING TO CITY AND NEARBY GOVERNMENT OFFICES

WHEREAS, national highways, provincial, city and municipal roads and streets are considered veins and arteries of every locality in ferrying passengers from all walks of life, transfer and exchange of commodities and goods;

WHEREAS, commuters in transit and on occasion of transfer and delivery of goods time is of great essence and any delay thereof would ultimately result to loss of productive man-hours and spoilage of perishable products;

WHEREAS, it been a common sight it being incessant and perennial that flooding along Maharlika Highway particularly at corner Barangay Road and Mahingan and at the perimeter of Duka Enterprises that flooding occurs during heavy rains to the detriment of the commuters;
