**RESOLUTION RESPECTFULLY REQUESTING HON. BERNADETTE “DETTE” G. ESCUDERO, 1<sup>st</sup> DISTRICT REPRESENTATIVE, PROVINCE OF SORSOGON TO ALLOCATE FUNDS INTENDED FOR THE REHABILITATION OF THE BEACHFRONT FACING PUROK 1 OF BARANGAY CARICARAN, BACON DISTRICT, SORSOGON CITY**

**WHEREAS**, the beachfront facing Purok 1 of Barangay was occupied by several well-known tourist destination beach resorts, which have been the backbone of the economy of the barangay and residents therein involved in tourism industry;

**WHEREAS**, by sudden struck of high tides, the 20 meter sea sand of the beachfront was already occupied by the sea water extending up to some or several beach resorts located therein;

**WHEREAS**, reports of some minimal to major damages to beach resort's premises, structures and properties caused by the seawaters during high tides were documented thereby at Jams Beach Resort, Baywalk Beach Resort, Hubs Beach Resort and at Ohana Beach Resort;

**WHEREAS**, it was also reported that some public cottages, flag poles and beach lights were also destroyed;

**WHEREAS**, this phenomena may be attributed to the natural effects of nature wherein the waves make the coastline and beachfront closer to the resorts, to include the effects of natural calamities and climate change;

**WHEREAS**, the people of Barangay Caricaran, particularly those involved in tourism industry, appealed to the City Government to rehabilitate if not restored, the original or previous landscape and aesthetic condition of the said beachfront;

**WHEREAS**, seawalls, and bulkheads maybe introduced and be constructed thereon to combat erosion and to maintain development at an advanced position from the natural shoreline or any feasible and most appropriate protective measures may apply for the purpose, hence, this request;

**NOW THEREFORE**, on motion of **Hon. Reynaldo C. Taladtad**, duly seconded by **Hon. Danilo A. Deladia**, resolved as it is hereby resolve to respectfully request Hon. Bernadette " Dette" G. Escudero, 1<sup>st</sup> District Representative, Province of Sorsogon to allocate funds intended for the rehabilitation of the Beachfront facing Purok 1 of Barangay Caricaran, Bacon District, Sorsogon City.
