RESOLUTION ADOPTING LOCAL BUDGET CIRCULAR NO. 148 DATED DECEMBER 23, 2022 GRANTING HONORARIUM TO ALL SANGGUNIANG KABATAAN (SK) MEMBERS, SK SECRETARIES AND SK TREASURERS OF THE 64 BARANGAYS OF THE CITY OF SORSOGON, PRESCRIBING GUIDELINES FOR ITS IMPLEMENTATION, PROVIDING FUNDS THEREFOR AND FOR OTHER PURPOSES

WHEREAS, on December 23, 2022, the Department of Budget and Management (DBM) issued Local Budget Circular No. 148 addressed to the Local Chief Executives, Members of the Local Sanggunian, Local Budget Officers, Local Treasurers, Local Planning and Development Coordinators, Local Accountants, Local Youth Development Officers, Sangguniang Kabataan (SK) Chairpersons, Members of the SK, SK Treasurers and SK Secretaries by prescribing guidelines and procedures on the grant of honorarium to SK Members, SK Treasurer and SK Secretary pursuant to Section 4 of RA No. 11768 ;

WHEREAS, as therein stated, SK Officials shall each receive a monthly honorarium, chargeable against the SK Funds, in addition to any other compensation and shall be granted at the end of the month;

WHEREAS, the honorarium is a financial assistance that may serve as an instrument in helping the Sangguniang Kabataan perform their tasks and various duties, such as an aid that will allow to defray at least their transportation cost when attending meetings and other responsibilities to actively promote the welfare of the youth in their barangays;

WHEREAS, preceding statements considered, the 8th City Council recognizes the importance of the Sangguniang Kabataan and its members in their efforts to perform equally important duties and responsibilities as youth leaders in their barangay;

WHEREAS, foregoing premises considered and after due deliberation on the matter, the 8th City Council deemed it necessary to pass a resolution adopting the implementing guidelines on the grant of honorarium to SK Officials pursuant to Republic Act No. 11768;


NOW THEREFORE, on motion of **Hon. Renalene Mae J. Duka** duly seconded by **Hon. Jo Abegail C. Dioneda** resolve as it is hereby resolved to adopt Local Budget Circular No. 148 dated December 23, 2021, granting honorarium to all Sangguniang Kabataan (SK) members, SK Secretaries and SK Treasurers of the 64 barangays of the City of Sorsogon, prescribing guidelines for its implementation, providing funds therefor and for other purposes.
