RESOLUTION REITERATING THE REQUEST OF THE 8TH CITY COUNCIL FOR THE CITY ENGINEERING OFFICE TO CONDUCT DECLOGGING AND OF DRAINAGE SYSTEM, RIVERS AND TRIBUTARIES IN THE CITY OF SORSOGON IN ANTICIPATION OF THE COMING RAINY SEASON.

WHEREAS, on August 30, 2022, the Hon. Lester R. Lubiano authored a resolution entitled "RESOLUTION RESPECTFULLY REQUESTING THE CITY ENGINEER'S OFFICE TO CONDUCT DECLOGGING OF DRAINAGE SYSTEM, RIVERS AND TRIBUTARIES IN THE CITY OF SORSOGON IN ANTICIPATION FOR THE COMING RAINY SEASON".

WHEREAS, the intent of the resolution is for the City Engineering Office to conduct inspection and declogging of drainage systems, rivers and tributaries in order to mitigate flooding in identified areas of Sorsogon City;

WHEREAS, the 8th City Council also adopted and 7k Program of the Hon. Edwin "Boboy" Hamor, Governor, Province of Sorsogon wherein among this is Kalinisan and Kalikasan" which definitely has outmost congruence to the intent of this resolution;

WHEREAS, at present, several areas of Sorsogon City experienced severe flooding due to heavy rainfall for days resulting to series of Suspension of Classes to include workers in the government and private institutions;

WHEREAS, in order to protect the lives and property of our local constituents against imment dangers of flooding, there is a need to pursue the conduct of declogging of drainage system, rivers and tributaries in the territorial jurisdiction of the city considering the present heavy downpour of rains being experienced in the city;

WHEREAS, foregoing premise considered and after due deliberation on the matter, the 8^{th} City Council deemed it necessary to pass a resolution reiterating the request of the 8^{th} City Council for the City Engineering Office to conduct declogging and of drainage system, rivers and tributaries in the City of Sorsogon in anticipation of the coming rainy season;

NOW THEREFORE, on motion of **Hon. Lester R. Lubiano** duly seconded by **Hon. Danilo A. Deladia** as it is hereby resolved to reiterate the request of the 8th City Council for the City Engineering Office to conduct declogging and of drainage system, rivers and tributaries in the City of Sorsogon in anticipation of the coming rainy season;
