RESOLUTION EXTENDING THE DEADLINE FOR THE PAYMENT OF BUSINESS TAXES, FEES AND CHARGES UNTIL FEBRUARY 15, 2023.

WHEREAS, the City Government will conduct its statutory and traditional Annual Business One-Stop-Shop (BOSS) for CY 2023 on January 3-31, 2023 wherein all regulatory offices that are involved in the issuance of Mayor's/Business Permit will be situated in at the city hall lobby;

WHEREAS, adapting the new normal amid Covid 19 Pandemic, the Executive Department has formulated or designed new system and strategies following the minimum health and safety protocols, such as the wearing of face mask, face shields and observance of social distancing;

WHEREAS, the strategy involved the scheduling of applications of renewal per barangay and a limited to one hundred sixty (160) applications to be accommodated per day;

WHEREAS, due to the economic hardship brought about by Covid19 Pandemic, the City Government intends to provide the business sector an ample opportunity and time to pay for the fees and charges until **February 15, 2023**;

NOW THEREFORE, on incidental motion of **Hon. Nestor J. Baldon** duly seconded by **Hon. Peer Joseph J. Ravanilla**, resolved as it is hereby resolve to extend the deadline for the payment of business taxes, fees and charges until February 15, 2023.
