RESOLUTION DECLARING VALID BARANGAY RESOLUTION NO. 11-01, SERIES OF 2022 OF THE BARANGAY COUNCIL OF ABUYOG, EAST DISTRICT, SORSOGON CITY ENTITLED "RESOLUTION ENACTING AN ORDINANCE AMENDING THE TAX CODE OF BARANGAY ABUYOG, EAST DISTRICT, SORSOGON CITY"

WHEREAS, Committee Report No. 010, Series of 2023 of the Committee on Rules and internal Affairs, with a subject, "Resolution No. 11-01, Series of 2022 from the Barangay Council of Abuyog, East District, Sorsogon City entitled, "RESOLUTION ENACTING AN ORDINANCE AMENDING THE TAX CODE OF BARANGAY ABUYOG, EAST DISTRICT, SORSOGON CITY" was among the items deliberated upon by the 8th City Council during the January 24, 2023 Regular Session;

WHEREAS, foregoing premise considered and after due deliberation on the matter, the 8th City Council deemed it necessary to pass a resolution declaring valid Barangay Resolution No. 11-01, Series of 2022 from the Barangay Council of Barangay Abuyog, East District, Sorsogon City entitled "RESOLUTION ENACTING AN ORDINANCE AMENDING THE TAX CODE OF BARANGAY ABUYOG, EAST DISTRICT, SORSOGON CITY";
