RESOLUTION RESPECTFULLY REQUESTING HON. MA. ESTER E. HAMOR, CITY MAYOR, TO ALLOCATE FUNDS INTENDED FOR THE CONSTRUCTION OF A CONCRETE PATHWAY FROM THE STAIRCASE ALONGSIDE THE COASTAL ROAD CONNECTING TO THE CONCRETE PATHWAY GOING TO BITA-O ELEMENTARY SCHOOL, BARANGAY BITAN-O, WEST DISTRICT, SORSOGON CITY

WHEREAS, the Chairman of the Committee on Education, Arts, Culture and Heritage was in receipt of letter, dated December 27, 2022, from Ms. Elsa O. Racadag, President of the Teachers Organization of Bitan-o Elementary School and project proponent;

WHEREAS, the letter contains their appeal for assistance from the city government for the construction of a concrete pathway from the staircase alongside the

coastal road connecting to the concrete pathway going to Bitan-o Elementary School, Barangay Pangpang, West District, Sorsogon City;

WHEREAS, the construction of a concrete pathway from the side of the coastal road going to Bitan-o Elementary School is of great need for commuters, especially for pupils and teachers of Bitan-o Elementary School;

WHEREAS, the proposal is for the construction of a concrete pathway with a proposed size of more or less 10m x 1m (length and width);

WHEREAS, although there is already concrete pathway at the other side located from the boulevard area going to the school, the proposed pathway near the coastal road is far more preferred by teachers and pupils who reside alongside the coastal road and neighboring sitios;

WHEREAS, the existing pathway is swampy and toiled with sea shells so much so that it pauses danger for slides and soaked-to-wet shoes and feet, especially during rainy days;

NOW THEREFORE, on motion of **Hon. Ma. Teresa D. Perdigon**, duly seconded by **Hon. Renalene Mae J. Duka**, resolved as it is hereby resolve to request Hon. Ma. Ester E. Hamor, City Mayor, to allocate funds intended for the construction of a concrete pathway from the staircase alongside the coastal road connecting to the concrete pathway going to Bitan-o Elementary School, Barangay Bitan-o, West District, Sorsogon City.
