RESOLUTION APPROVING AND AUTHORIZING THE CONDUCT OF BRACKET THREE (3) 1 COCK/ STAG ULUTAN FASTEST WIN ON FEBRUARY 16, 2023 SPONSORED BY PJ DIONEDA AT THE SORSOGON CENTRAL COCKPIT, BARANGAY BIBINCAHAN, EAST DISTRICT, SORSOGON CITY FOR THE BENEFIT OF SENIOR CITIZENS OF BRGY. CAPUY, WEST DISTRICT, SORSOGON CITY

WHEREAS, among the items deliberated during the January 31, 2023 Regular Session of the 8th City Council was the letter from Mr. PJ Dioneda addressed to Hon. Nestor J. Baldon, City Councilor, Sorsogon City dated January 25, 2023 relative to the request for a conduct of bracket three (3) 1 cock/stag fastest win on February 16, 2023 at Sorsogon City Cockpit Coliseum, Brgy. Bibincahan, East District, Sorsogon City for the benefit of Senior Citizen of Brgy. Capuy, West District, Sorsogon City;

WHEREAS, as per consensus, a certain amount of the total share of the requesting party from the derby shall be reserved and retained by the Committee on Games and Amusement through the owner of the cockpit and shall be given to the respective charitable institution (SENIOR CITIZENS OF BRGY. CAPUY, WEST DISTRICT, SORSOGON CITY) and that the party shall faithfully comply therewith;

WHEREAS, pursuant to Inter Agency Task Force on Covid19 (IATF) Resolution No. 154, Series of 2021 and to the existing laws and regulations and as provided by Republic Act 7160 otherwise known as the Local Government Code of 1991, the Sangguniang Panlungsod has the power to regulate the conduct of cockfighting within the territorial jurisdiction of the City;

WHEREAS, foregoing premises considered and after due deliberation on the matter, the 8th City Council deemed it necessary to pass a resolution approving and authorizing the conduct of bracket three (3) 1 cock/stag fastest win on February 16, 2023 at Sorsogon City Cockpit Coliseum, Brgy. Bibincahan, East District, Sorsogon City for the benefit of Senior Citizen of Brgy. Capuy, West District, Sorsogon City;
