RESOLUTION ADOPTING DILG MEMORANDUM CIRCULAR NO. 2023-001 DATED JANUARY 3, 2023 RELATIVE TO HALINA'T MAGTANIM NG PRUTAS AT GULAY (HAPAG) SA BARANGAY PROJECT AND THEREBY REQUESTING THE 64 BARANGAYS OF THE CITY OF SORSOGON FOR ITS SUPPORT AND IMPLEMENTATION OF THE SAME

WHEREAS, the economy of the Philippines depends heavily on the agricultural sector, thus challenges encountered, especially by farmers, have negative effects on the food security in the country;

WHEREAS, given its geographic location, the Philippines to include the City of Sorsogon experienced numerous threats to food security brought about by strings of natural calamities that have rendered farm produce unusable or increased food prices due to food shortage;

WHEREAS, the Memorandum Circular was issued to provide guidelines for the establishment of a Barangay Community Garden that will serve as a strategy to diversify the food source and contribute to ensuring food security in the community;

WHEREAS, thus, in support to the DILG MC 2023-001, to the Tanging Yaman Program under the Ten points Agenda + 1 of the Hon. Ma. Ester E. Hamor and cognizant of the role of barangays as essential partners of the national government in contributing to addressing hunger, and ensuring food security in the country, the Department of the Interior and Local Government (DILG) is introducing the HALINA'T MAGTANIM ng PRUTAS at GULAY (HAPAG) sa BARANGAY PROJECT ;

WHEREAS, Section 16 of the Philippine Constitution provides that “the State shall protect and advance the right of the people to a balanced and healthful ecology in accord with the rhythm and harmony of nature;

NOW THEREFORE on motion of **Hon. Bessie C. Diaz** duly seconded by **Hon. Danilo A. Deladia**, resolve as it is hereby resolved to adopt DILG Memorandum Circular No. 2023-001 dated January 3, 2023 relative to Halina't Magtanim ng Prutas at Gulay (HAPAG) sa Barangay Project and thereby requesting the 64 barangays of the City of Sorsogon for its support and implementation of the same.
