RESOLUTION ISSUING TRICYCLE FRANCHISE TO TWO (2) QUALIFIED WAITING APPLICANTS FROM PREVIOUSLY CANCELLED/REVOKED TRICYCLE FRANCHISES UNDER SP RESOLUTION NO. 068, SERIES OF 2022 IN ACCORDANCE WITH CITY ORDINANCE NO. 22, SERIES OF 2020 OTHERWISE KNOWN AS THE "SORSOGON CITY NEW TRICYCLE FRANCHISE CODE OF 2020"

NOW THEREFORE, on incidental motion of **Hon. Nestor J. Baldon** seconded by **Hon. Rendelene Mae J. Duka**, resolved as it is hereby resolve to issue tricycle franchise two (2) qualified waiting applicants from previously cancelled/revoked tricycle franchises under SP Resolution No. 068, Series of 2023 in accordance with City Ordinance No. 22, Series of 2020 otherwise known as the "Sorsogon City New Tricycle Franchise Code of 2020".

WHEREAS, Section 14 of City Ordinance No. 22-2020 ("Sorsogon City New Tricycle Franchise Code of 2020") provides that The Sangguniang Panlungsod shall issue/grant franchise to operate a motorized tricycle for hire to qualified persons who desire to provide transport service to the general public by means of a motorized tricycle for monetary consideration. Being a privilege, it can be revoked, cancelled or withdrawn unilaterally at any time upon reasonable grounds;

1. Tricycle Franchise No. 0837/Tricycle Franchise Plate No. 0837 awarded in the name of **TRECE E. DOGILLO** of Sulucan, East District Sorsogon City, with the route covered by PTODA
2. Tricycle Franchise No. 4375/Tricycle Franchise Plate No. 4375 awarded in the name of **GILBERT JANABA** of San Juan, East District Sorsogon City, with the route covered by SJEDTODA
