RESOLUTION ADOPTING, APPROVING AND ENACTMENT OF AN ORDINANCE OF THE CITY DEVELOPMENT COUNCIL -EXECUTIVE COMMITTEE RESOLUTION NO. 01, SERIES OF 2023 ENTITLED "RESOLUTION APPROVING THE REAPPROPRIATION OF THE 2021 AND 2022 20% DEVELOPMENT FUND BALANCES AMOUNTING TO TEN MILLION FOUR HUNDRED SIXTEEN THOUSAND FIFTEEN AND 21/100 (P10,416,015.21) AND INCORPORATING IT WITH THE 2023 20% DEVELOPMENT FUND"

WHEREAS, on February 3, 2023, the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City wrote a letter addressed to the Honorable Members of the Sangguniang Panlungsod thru Hon. Mark Eric C. Dioneda, City Vice Mayor, Sorsogon City respectfully requesting among others, enactment of appropriation ordinance, adoption, approval of City Development Council (CDC) Executive Committee Resolution No. 01, Series of 2023 entitled "Resolution approving the Reappropriation of the 2021 And 2022 20% Development Fund Balances Amounting To Ten Million Four Hundred Sixteen Thousand Fifteen And 21/100 (P10,416,015.21) and incorporating it with the 2023 20% Development Fund";

WHEREAS, the Local Government Unit of Sorsogon City in compliance with Republic Act 7160 otherwise known as the Local Government Code of 1991 particularly Section 106 sets to implement projects, programs and activities in the direction of economic and social development in the Local Government;

WHEREAS, the projects under the 2021 and 2022 Development Fund were implemented and as of December 2022, balances amounting to ₱10,416,015.21 were earned and there is a need to re-appropriate the unexpended balances to enable the City Government to fully deliver the best services to its constituents;

WHEREAS, foregoing premise considered and after due deliberation on the matter, the 8th City Council deemed it necessary to enact an appropriation ordinance, adoption, approval of City Development Council (CDC) Executive Committee Resolution No. 01, Series of 2023 entitled “Resolution approving the Re-appropriation of the 2021 And 2022 20% Development Fund Balances Amounting To Ten Million Four Hundred Sixteen Thousand Fifteen And 21/100 (₱10,416,015.21) and incorporating it with the 2023 20% Development Fund” ;
