CHRISTINE N. MERALPES, CITY ACCOUNTANT AS AUTHORIZED REPRESENTATIVE RELATIVE TO THE ELECTRONIC TAX PAYMENT SYSTEM FACILITY APPLICATION WITH THE LAND BANK OF THE PHILIPPINES (LBP)
