# Resolution No. 085, Series of 2023

RESOLUTION ENACTING AN ORDINANCE PROVIDING SUPPLEMENTAL PROVISION TO THE COCKPIT FRANCHISE ISSUED TO MR. RICO ORTIZ AND THEREBY AMENDING SECTION 3 OF CITY ORDINANCE NO. 006, SERIES OF 2019 OTHERWISE KNOWN AS THE ORDINANCE GRANTING COCKPIT FRANCHISE TO SORSOGON CENTRAL COCKPIT COLISEUM LOCATED AT BARANGAY BIBINCAHAN, EAST DISTRICT, SORSOGON CITY

**WHEREAS**, it is a declared policy of the City Government of Sorsogon to issue within framework of the society maximum development and promotion of wholesome recreation and amusement beneficial to the people;

**WHEREAS**, Section 458 (3)(v) of Republic Act 7160, otherwise known as the Local Government Code of 1991 authorizes through an ordinance the establishment, operation and maintenance of cockpits, and regulate the cockfighting and commercial breeding of gamecocks;

**WHEREAS**, Section 5 (b) of Presidential Decree 449 or the "Cockfighting Law of 1974" states that only one cockpit shall be allowed in each city or municipality, except that in cities or municipalities with a population of over one hundred thousand, two cockpits may be established, maintained and operated;

**WHEREAS**, Section 3 of City Ordinance No. 006, series of 2019 otherwise known as the ordinance granting cockpit franchise to Sorsogon Central Cockpit Coliseum located at Barangay Bibincahan, East District, Sorsogon City provides no expiration of franchise, while City Ordinance No. 07, Series of 2021 provides the authority to operate and maintain a cockpit arena for a period of twenty five years to 2020 ME OPC doing business under the name and style of Guinlajon Cockpit Coliseum;

**WHEREAS**, this measure intends to rectify the validity of cockpit franchise issued to Mr. Rico Ortiz under Section 3 of City Ordinance No. 006, series of 2019 for purposes of fairness, equality and impartiality to all cockpit franchise holders;

**NOW THEREFORE**, on motion of **Hon. Nestor J. Baldon**, duly seconded by **Hon. Jo Abegail C. Dioneda**, resolved as it is hereby done to enact an ordinance providing supplemental provision to the cockpit franchise issued to Mr. Rico Ortiz and thereby amending Section 3 of City Ordinance No. 006, series of 2019 otherwise known as the ordinance granting cockpit franchise to Sorsogon Central Cockpit Coliseum located at Barangay Bibincahan, East District, Sorsogon City.

# City Ordinance No. 08, Series of 2023

AN ORDINANCE PROVIDING SUPPLEMENTAL PROVISION TO THE COCKPIT FRANCHISE ISSUED TO MR. RICO ORTIZ AND THEREBY AMENDING SECTION 3 OF CITY ORDINANCE NO. 006, SERIES OF 2019 OTHERWISE KNOWN AS THE ORDINANCE GRANTING COCKPIT FRANCHISE TO SORSOGON CENTRAL COCKPIT COLISEUM LOCATED AT BARANGAY BIBINCAHAN, EAST DISTRICT, SORSOGON CITY

**Be it ordained** by the 8<sup>th</sup> City Council of Sorsogon in session assembled that:

#### SECTION 1 TITLE

This ordinance shall be known as the "Supplemental Provision for the validity and duration of Sorsogon Central Cockpit Coliseum Franchise Ordinance of 2023"

### SECTION 2 SCOPE/COVERAGE

This ordinance shall cover the authority to operate and maintain a cockpit arena to Sorsogon Central Cockpit Coliseum located at Barangay Bibincahan, East District, Sorsogon City.

# SECTION 3 SUPPLEMENTAL PROVISION AND AMENDMENT TO SECTION 3 OF CITY ORDINANCE NO. 006, SERIES OF 2019

A franchise to operate and maintain a cockpit is hereby issued/granted for a period of Twenty Five (25) Years to Sorsogon Central Cockpit Coliseum reckoned on the date of effectivity of City Ordinance No. 006, Series of 2019.

### SECTION 4 REPEALING CLAUSE

All ordinances, resolutions and regulations, or any part(s) thereof which are inconsistent with any provisions of this ordinance are hereby repealed or modified accordingly.

### SECTION 5 SEPARABILITY CLAUSE

If for any reason or reasons, any part or provision of this ordinance shall be held to be unconstitutional or invalid, other parts or provision hereof which are not affected thereby shall continue to be in full force and effect.

### SECTION 6 EFFECTIVITY

This ordinance shall take effect immediately upon its approval by the Sangguniang Panlungsod and after compliance with the law on public dissemination and of publication.
