**RESOLUTION APPROVING AND AUTHORIZING THE CONDUCT OF FOUR (4) STAG PRE-FINALS ON MARCH 9, 2023 (NIGHT TIME) SPONSORED BY PROUD BIKOLANO BREEDERS AND COCKERS (PBB & C) AT SORSOGON CITY CENTRAL COCKPIT COLISEUM, BARANGAY BIBINCAHAN, EAST DISTRICT, SORSOGON CITY**

**WHEREAS**, among the items deliberated during the February 14, 2023 Regular Session of the 8th City Council was the letter from Mr. Alladin Caubang addressed to Hon. Nestor J. Baldon, City Councilor, Sorsogon City dated February 6, 2023 relative to the request for a conduct of Four (4) Stag Pre-Finals on March 9, 2023 (Night Time) sponsored by Proud Bikolano Breeders And Cockers (PBB & C) at Sorsogon City Central Cockpit Coliseum, Barangay Bibincahan, East District, Sorsogon City;

**WHEREAS**, as per consensus, a certain amount of the total share of the requesting party from the derby shall be reserved and retained by the Committee on Games and Amusement through the owner of the cockpit and shall be given to the respective charitable institution (BATCH 1998) and that the party shall faithfully comply therewith;

**WHEREAS**, pursuant to Inter Agency Task Force on Covid19 (IATF) Resolution No. 154, Series of 2021 and to the existing laws and regulations and as provided by Republic Act 7160 otherwise known as the Local Government Code of 1991, the Sangguniang Panlungsod has the power to regulate the conduct of cockfighting within the territorial jurisdiction of the City;

**WHEREAS**, foregoing premises considered and after due deliberation on the matter, the 8<sup>th</sup> City Council deemed it necessary to pass a resolution approving and authorizing the conduct Four (4) Stag Pre-Finals on March 9, 2023 (Night Time) sponsored by Proud Bikolano Breeders and Cockers (PBB & C) at Sorsogon City Central Cockpit Coliseum, Barangay Bibincahan, East District, Sorsogon City;

**NOW THEREFORE**, on incidental motion of **Hon. Nestor J. Baldon**, duly seconded by **Hon. Danilo A. Deladia**, resolved as it is hereby resolve to approve and authorize the conduct of Four (4) Stag Pre-Finals on March 9, 2023 (Night Time) sponsored by Proud Bikolano Breeders And Cockers (PBB & C) at Sorsogon City Central Cockpit Coliseum, Barangay Bibincahan, East District, Sorsogon City;
