RESOLUTION MOST RESPECTFULLY REQUESTING HON. MA. ESTER E. HAMOR, CITY MAYOR, SORSOGON CITY TO CONDUCT A ONE DAY TRAINING AND SEMINAR FOR SK CHAIRPERSONS AND SK TREASURERS OF THE 64 BARANGAYS IN THE CITY OF SORSOGON RELATIVE TO THE UTILIZATION OF THE BUDGET OF THE SANGGUNIANG KABATAAN PURSUANT TO THE DEPARTMENT OF BUDGET AND MANAGEMENT LOCAL BUDGET CIRCULAR 148, DATED DECEMBER 23, 2022

WHEREAS, the City of Sorsogon believes in the importance of the Sorsoganon youth in nation-building and the development of young leaders who will lead this City and nation in the future is imperative;

WHEREAS, the measure aims to conduct training and seminar for the SK Chairpersons and SK Treasurers of the 64 barangays in the City of Sorsogon for the administration and proper

disbursement of SK budget in the barangay pursuant to DBM Local Budget Circular 148, dated December 23, 2022;

WHEREAS, the Sangguniang Kabataan Treasurers really need this training in order to properly disburse and manage the SK budget especially now that there is a need to give an honorarium to SK Members, SK Secretaries and SK Treasurers;

WHEREAS, the Sangguniang Kabataan is also appealing to the Executive Department to shoulder the expenses for the training to be conducted;
