RESOLUTION INTERPOSING NO OBJECTION TO THE INTENT OF MS. NENITA ARAMBURO YEE TO FACILITATE THE TITLING OF A PROPERTY DESIGNATED AS LOT NO 3462-A SITUATED AT BARANGAY SULUCAN, EAST DISTRICT, SORSOGON CITY REGISTERED UNDER TAX DECLARATION NO. 2011-02-0014-00062.

WHEREAS, on January 09, 2023, Ms. Nenita Aramburo Yee wrote a letter addressed to the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City respectfully requesting for the passage of a resolution interposing no objection on her intent to facilitate titling of a property designated as Lot No 3462-A situated at Barangay Sulucan, East District, Sorsogon City registered under Tax Declaration No. 2011-02-0014-00062;

WHEREAS, the same officially transmitted to the legislative department through Transmittal No. 02, series of 2023 addressed to the Hon. Mark Eric C. Dioneda, City Vice Mayor,

was among the items deliberated upon by the 8th City Council during the January 17, 2023 Regular Session and was then referred to the Committee on Land Use;

WHEREAS, on February 08, 2023 a committee hearing was conducted by the Committee on Land Use duly attended by a representative from the requesting party, concerned department heads, rer4epsentative from the Department of Environment and Natural Resources and Members of the Committee on Land Use;

whereas, perusal of the documents submitted showed that the applicant had been in possession of the lot at issue for decades and the requested resolution is among the documents being required by the Department of Environment and Natural Resources (DENR) in connection with the intent of the applicant to secure a title of the lot at issue pursuant to Republic Act 10023 otherwise known as the Free Patent for Residential Lands Act;

WHEREAS, department heads concerned present during the committee hearing also expressed their non-objection on the applicants request and the applicant secures a certification from City Planning and Development Office;

WHEREAS, foregoing premise considered and after due deliberation on the matter, the 8th City Council deemed it necessary to pass a resolution interposing no objection on her intent to facilitate titling of a property designated as Lot No 3462-A situated at Barangay Sulucan, East District, Sorsogon City registered under Tax Declaration No. 2011-02-0014-00062;

NOW THEREFORE, on motion **Hon. Nestor J. Baldon** duly seconded by **Hon. Renalene Mae J. Duka**, resolve as it is hereby resolved to interpose no objection on her intent to facilitate titling of a property designated as Lot No 3462-A situated at Barangay Sulucan, East District, Sorsogon City registered under Tax Declaration No. 2011-02-0014-00062;
