RESOLUTION APPROVING THE APPLICATION FOR PRELIMINARY APPROVAL AND LOCATIONAL CLEARANCE (PALC) AND DEVELOPMENT PERMIT (DP) FILED BY THE PROVINCIAL GOVERNMENT OF SORSOGON REPRESENTED BY HON. EDWIN “BOBOY” HAMOR, GOVERNOR, PROVINCE OF SORSOGON IN CONNECTION WITH CABID-AN RESETTLEMENT PROJECT PHASE I SUBDIVISION SCHEME SITUATED AT LOT 4095 (PT.), BARANGAY CABID-AN, EAST DISTRICT, SORSOGON CITY.

WHEREAS, on January 09, 2023, the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City endorsed to the 8th City Council Transmittal No. 07, series of 2023 addressed to the Hon. Mark Eric C. Dioneda, City Vice Mayor respectfully requesting for appropriate legislation in relation to the application for Preliminary Approval and Locational Clearance (PALC) and Development Permit (DP) filed by the Provincial Government of Sorsogon represented by Hon. Edwin “Buboy” Hamor, Governor, Province of Sorsogon in connection with Cabid-An Resettlement Project Phase I Subdivision Scheme situated at Lot 4095 (Pt.), Barangay Cabid-an, East District, Sorsogon City;

WHEREAS, the same was among the items deliberated upon by the 8th City Council during the January 31, 2023 Regular Session and was eventually referred to the Committee on Land Use, Housing and Urban Planning;

WHEREAS, on February 08, 2023, a committee hearing was conducted for this purpose inviting the presence of all concerned;

WHEREAS, perusal of the documents submitted and as presented by representatives from the Provincial Government, said endeavour is among the priority programs wherein the area at issue shall be utilized as a Resettlement Area thereby favoring informal settlers in our locality;

WHEREAS, foregoing premise considered and after due deliberation on the matter, the 8th City Council deemed it necessary to pass a resolution approving the application for Preliminary Approval and Locational Clearance (PALC) and Development Permit (DP) filed by the Provincial Government of Sorsogon represented by Hon. Edwin “Buboy” Hamor, Governor, Province of Sorsogon in connection with Cabid-An Resettlement Project Phase I Subdivision Scheme situated at Lot 4095 (Pt.), Barangay Cabid-an, East District, Sorsogon City;


