RESOLUTION AUTHORIZING THE HON. MA. ESTER E. HAMOR, CITY MAYOR, SORSOGON CITY TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE PROVINCIAL GOVERNMENT OF SORSOGON REPRESENTED BY PROVINCIAL GOVERNOR EDWIN "BOBOY" B. HAMOR RELATIVE TO THE FINANCIAL ASSISTANCE TO BE UTILIZED BY EVERY LOCAL GOVERNMENT UNIT IN THE PROVINCE OF SORSOGON FOR THE 2023 INTER CITY/MUNICIPALITY BASKETBALL TOURNAMENT SEASON 2.

**WHEREAS**, among the items deliberated during the February 14, 2023 Regular Session of the 8th City Council is a Memorandum of Agreement (MOA) with the Provincial Government of Sorsogon represented by Hon. Edwin "Boboy" B. Hamor, Governor, Province of Sorsogon relative to the financial assistance for the 2023 Inter City/Municipality Basketball Tournament Season 2;

**WHEREAS**, the City of Sorsogon is a recipient of Three Hundred Thousand (₱300,000.00) Pesos from the Provincial Government of Sorsogon which is allocated for East, West and Bacon Districts to

augment its meager resources to defray the expenses that may be incurred in the 2023 Inter City/Municipality Basketball Tournament Season 2;

WHEREAS, Article XIV, Section 19 of the 1987 Philippine Constitution provides that, "(1)The State shall promote physical education and encourage sports programs, league competitions, and amateur sports, including training for international competitions, to foster self-discipline, teamwork, and excellence for the development of a healthy and alert citizenry. (2) All educational institutions shall undertake regular sports activities throughout the country in cooperation with athletic clubs and other sectors"

WHEREAS, to bring the youth and adult teams together for fun and friendly competition to cultivate a spirit of camaraderie, sportsmanship, and goodwill among the participating teams/players;

WHEREAS, the Provincial Government intends to enhance the popularity of basketball as a sport which will not only instill person discipline, vision and fortitude to participating team/players, but also offers a most challenging avocation that channels the mind to healthy pursuit that will undoubtedly redound to combating drug addiction and juvenile delinquency, hence, it is a key to youth development and valuable social skills;

WHEREAS, to fully support a common objective of a successful higher level athletic meets at this most challenging time, the parties have agreed to enter into this MOA;

NOW THEREFORE, on incidental motion of Hon. Renalene Mae J. Duka, duly seconded by Hon. Danilo A. Deladia, resolve as it is hereby resolved to authorize the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City to enter into a Memorandum of Agreement (MOA) with the Provincial Government of Sorsogon represented by Provincial Governor Edwin "Boboy" B. Hamor relative to the financial assistance to be utilized by every Local Government Unit in the Province of Sorsogon for the 2023 Inter City/Municipality Basketball Tournament Season 2;

RESOLVED FURTHER, that the Memorandum of Agreement entered into by parties herein mentioned shall be an integral part of this resolution and copies of the same be furnished to the Sangguniang Panlungsod for record and archive purposes;

**RESOLVED FINALLY**, that copies of this resolution be furnished to all concerned for their information and guidance.
