RESOLUTION APPROVING TWO (2) APPLICATION FOR CANCELLATION OF TRICYCLE FRANCHISE AND THEREBY AUTHORIZING QUALIFIED PRIORITY APPLICANT TO SUBSTITUTE OR REPLACE THE FORMER HOLDER THEREOF TO OPERATE TRICYCLE-FOR-HIRE IN THE CITY OF SORSOGON UNDER THE SAME FRANCHISE, MOTORCYCLE UNIT AND ROUTE OF OPERATION AS ALLOWED UNDER SECTION 13 OF CITY ORDINANCE NO. 22, SERIES OF 2020 OTHERWISE KNOWN AS THE "SORSOGON CITY NEW TRICYCLE FRANCHISE CODE OF 2020"

**WHEREAS**, the following was applied for dropping/cancellation of Tricycle Franchise due to the demise of the holder thereof with the Death Certificate attached and made integral part hereof, to wit:

1. **ALEXANDER F. JANORAS** of Barangay San Juan, East District, Sorsogon City, died on January 24, 2023, a grantee of a Tricycle Franchise No. 1454/Tricycle Franchise Plate No. 1454 for Tricycle-for-Hire with the route service under SJEDTODA, valid up to March 10, 2026 and with the following technical description, to wit:

2. **OSCAR L. LASALA** of Barangay Macabog, West District, Sorsogon City, died on December 16, 2022, a grantee of a Tricycle Franchise No. 2556/Tricycle Franchise Plate No. 2556 for Tricycle-for-Hire with the route service under MATRIODAS, valid up to January 27, 2026 and with the following technical description, to wit:

**WHEREAS**, Section 13 of City Ordinance No. 22-2020 (“Sorsogon City New Tricycle Franchise Code of 2020”) provides:

**SECTION 13 VALIDITY OF FRANCHISE**

Any franchise shall remain valid for a period three (3) years from the date of its issuance and shall be renewed on its anniversary date. If the anniversary date falls on a Saturday, Sunday or holiday or on the occasion of declared calamity the renewal shall be on the next working day immediately after.

The inaction of the grantee for a period of six (6) months after the expiration of tricycle franchise shall cause an automatic revocation of the privilege granted after 2 (two) notices.

Within six (6) months from the death of the franchise holder, the Certificate of Franchise shall be surrendered to the Sangguniang Panlungsod through CTFRO. The surviving spouse or any of his/her children shall be the priority applicant for the said recalled franchise. Failure to report and surrender the said franchise within the prescribed period shall be forfeited in favor of the city government and may be awarded to qualified waiting applicant.

**WHEREAS**, **ELISA A. JANORAS**, resident of Barangay San Juan, East District, Sorsogon City, heir of the deceased Alexander F. Janoras (Spouse) and **JULIE U. LASALA**, resident of Barangay Macabog, West District, Sorogon City heir of the deceased Oscar L. Lasala (Spouse), both applied to substitute or replace their deceased family member for the operation of tricycle –for-hire under the same franchise, in conformity with the provisions here above stated;

**WHEREAS**, the 8<sup>th</sup> City Council finds the herein application to be meritorious and the applicant is qualified to operate Tricycle-for-Hire in the City of Sorsogon under the same franchise, motorcycle unit and route of operation as allowed under Section 13 of City Ordinance No. 22, Series of 2020 otherwise known as the “Sorsogon City New Tricycle Franchise Code of 2020”.

**NOW THEREFORE**, on motion of **Hon. Nestor J. Baldon** duly seconded by **Hon. Danilo A. Deladia**, resolved as it is hereby resolve to approve the two (2) application for cancellation of tricycle franchise and thereby authorizing qualified priority applicant to substitute or replace the former holder thereof to operate Tricycle-for-Hire in the City of Sorsogon under the same franchise,

motorcycle unit and route of operation as allowed under Section 13 of City Ordinance No. 22, Series of 2020 otherwise known as the "Sorsogon City New Tricycle Franchise code of 2020".
