RESOLUTION ENDORSING THE RESOLUTIONS OF BARANGAY BUENAVISTA OF BACON DISTRICT, SORSOGON CITY TO THE DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES, DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS, TO HON. MA. ESTER E. HAMOR, CITY MAYOR, SORSOGON CITY AND OTHER CONCERNED GOVERNMENT AGENCIES FOR THE ALLOCATION OF FUNDS INTENDED FOR THE CONSTRUCTION OF FLOOD CONTROL AND DRAINAGE SYSTEM AT PUROK 5 AND PUROK 6 OF THE SAME BARANGAY

WHEREAS, the occurrence of heavy rains or typhoons brought about flooding and soil erosions that severely affected the constituents of Barangay Buenavista of Bacon District, Sorsogon City;

WHEREAS, it was discovered that the barangay has a sink hole located at the Buenavista National High School and at the Barangay Site where massive volume of water is flowing during heavy rains, to the discomfort of the barangay residents;

WHEREAS, barangay road is used as the access of residents and the general public in going to and from the national road and to different facilities, thus, drainage system thereat as a passageway of liquid wastes and rain waters is of utmost necessary;

WHEREAS, the existing road and drainage system, being obsolete due to long used has to be refurbished to avoid the recurrence of another massive flooding and soil erosions;

NOW THEREFORE, on motion of **Hon. Jo Abegail C. Dioneda**, duly seconded by **Hon. Bessie C. Diaz**, resolved as it is hereby resolve to endorse the resolutions of Barangay Buenavista of Bacon District, Sorsogon City to the Department of Environment and Natural Resources, Department of Public Works and Highways, to Hon. City Mayor Ma. Ester E. Hamor and other concerned government agencies for the allocation of funds intended for the construction of flood control and drainage system at Purok 5 and Purok 6 of the same barangay.
