RESOLUTION RESPECTFULLY REQUESTING THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS – SORSOGON FIRST ENGINEERING DISTRICT TO CONDUCT REMEDIAL AND/OR RESTORATION WORKS ON THE ROAD AFFECTED BY TORRENTIAL RAIN HAPPENED ON FEBRUARY 18-19, 2023, LOCATED AT BARANGAY BUENAVISTA, BACON DISTRICT, SORSOGON CITY

WHEREAS, on February 18 tom19, 2023, the Province of Sorsogon was placed to Weather Red Alert Level to which torrential rain was experienced throughout the place;

WHEREAS, torrential rain persists within two days for almost non-stop 48 hours wherein various flooding occurred elsewhere in the city of Sorsogon and of the province;

WHEREAS, mudflow and rain water flood were reported at Barangay Buenavista, Bacon District wherein portion of the road affected was closed to any vehicles;

WHEREAS, it was also reported that Puroks 5 and 6 of the said Barangay were greatly affected where the hole being the source of flooding was discovered with estimated length of 300 meters, with a wide of 5 to 10 meters and a deep of 10 meters and up;

WHEREAS, Puroks 3 and 4 were also partially affected extending up to Purok 7 thereof;

WHEREAS, after ocular inspection conducted for the purpose, it was concluded and identified that the main source of the said flooding was the rain water stocked in a hole and burst overflowed with considerable amount of mud contained therein spilled out along the road;

WHEREAS, residents of the said barangay believed that the said hole was intentionally made for a supposedly road opening, however, the project was suspended;

WHEREAS, remedial and/or restoration works on the road affected by the said torrential rain need to be immediately conducted to prevent any further loss of lives and properties and for the total convenience of the general public;

NOW THEREFORE, on motion of **Hon. Reynaldo C. Taladtad**, duly seconded by **Hon. Jo Abegail C. Dioneda**, resolved as it is hereby resolve to respectfully request the Department of Public Works and Highways – Sorsogon First Engineering District to conduct remedial and/or restoration works on the road affected by torrential rain happened on February 18-19, 2023, located at Barangay Buenavista, Bacon District, Sorsogon City.

RESOLVED FURTHER that copies of this resolution be furnished to all concerned for their information and guidance.
