**RESOLUTION APPROVING AND AUTHORIZING THE CONDUCT OF FOUR (4) STAG CLEAN-UP DERBY SPONSORED BY WORLD PITMASTER CUP NATIONAL (WPC) ON MARCH 19, 2023 (SUNDAY) AT THE SORSOGON CENTRAL COCKPIT COLISEUM, BARANGAY BIBINCAHAN, EAST DISTRICT, SORSOGON CITY FOR THE BENEFIT OF SENIOR CITIZENS OF BASUD, WEST DISTRICT, SORSOGON CITY**

**WHEREAS**, among the items deliberated during the February 28, 2023 Regular Session of the 8th City Council was the letter from Warren Lao, Promoter/Contact Person WPC, Sorsogon City Chapter addressed to Hon. Mark Eric C. Dioneda, City Vice Mayor Thru Hon. Nestor J. Baldon, City Councilor, Chairman on Games and Amusement, Sorsogon City dated February 22, 2023 relative to the request for a conduct of four (4) stag clean-up derby on March 19, 2023 (Sunday) at the Sorsogon Central Cockpit Coliseum, Barangay Bibincahan, East District, Sorsogon City;

**WHEREAS**, as per consensus, a certain amount of the total share of the requesting party from the derby shall be reserved and retained by the Committee on Games and Amusement through the owner of

the cockpit and shall be given to the respective charitable institution (**SENIOR CITIZENS OF BASUD, WEST DISTRICT, SORSOGON CITY**) and that the party shall faithfully comply therewith;

**WHEREAS**, pursuant to Inter Agency Task Force on Covid19 (IATF) Resolution No. 154, Series of 2021 and to the existing laws and regulations and as provided by Republic Act 7160 otherwise known as the Local Government Code of 1991, the Sangguniang Panlungsod has the power to regulate the conduct of cockfighting within the territorial jurisdiction of the City;

**WHEREAS**, foregoing premises considered and after due deliberation on the matter, the 8<sup>th</sup> City Council deemed it necessary to pass a resolution approving and authorizing the conduct of four (4) stag clean-up derby on March 19, 2023 (Sunday) at the Sorsogon Central Cockpit Coliseum, Barangay Bibincahan, East District, Sorsogon City;

**NOW THEREFORE**, on incidental motion of **Hon. Nestor J. Baldon**, duly seconded by **Hon. Renalene Mae J. Duka**, resolved as it is hereby resolve to approve and authorize the conduct of four (4) stag clean-up derby on March 19, 2023 (Sunday) at the Sorsogon Central Cockpit Coliseum, Barangay Bibincahan, East District, Sorsogon City;

**RESOLVED FURTHER**, that fees and charges appurtenant thereto shall be paid to the City Treasurer's Office prior to the conduct of the activity;
