RESOLUTION ENJOINING ALL BARANGAY COUNCIL OF THE 64 BARANGAYS IN THE CITY OF SORSOGON TO CONDUCT INFORMATION DISSEMINATION CAMPAIGN AND PROVIDE ASSISTANCE IN THE REGISTRATION OF SUBSCRIBER IDENTITY MODULE (SIM) CARDS OF BARANGAY RESIDENTS IN CONSONANCE WITH REPUBLIC ACT NO. 11934 OTHERWISE KNOWN AS "SUBSCRIBER IDENTITY MODULE (SIM) REGISTRATION ACT".

WHEREAS, under Section 12 Republic Act NO. 11934 (RA 11934), otherwise known as the "Subscriber Identity Module (SIM) Registration Act", the NTC, in coordination with other concerned agencies such as, but not limited to the Department of Information and Communications Technology (DCIT), Department of Trade and Industry (DTI), National Privacy Commission (NPC), as well as Public Telecommunications Entities (PTEs) and major consumer groups, shall set the guidelines for the monitoring and proper implementation of the said Act and shall promulgate the implementing rules and regulations as may be necessary to ensure the effective implementation of said Act;

WHEREAS, Republic Act No. 7925 (RA 7925), otherwise known as the “Public Telecommunications Policy Act” likewise recognizes the essential role of telecommunications in economic development, integrity and security of the Philippines, and such shall be social and political fabric of the Philippines;

WHEREAS, Department of Information and Communications Technology announced the deadline of SIM Registration on April 26, 2023, failure to register an existing SIM within the period prescribed shall result to the automatic deactivation of the Subscriber Identity Module (SIM) and deactivated SIM may only be reactivated after registration, provided that such reactivation was made not later than five days after such automatic deactivation;

WHEREAS, many of our barangay constituents are still unaware of the said law, thus the barangay council plays a vital role in the effective and efficient implementation of this national regulations in the barangay level;

WHEREAS, in addition thereto, our Senior Citizens and Persons with Disabilities (PWDs) are vulnerable sectors of our society who needs outmost priority following the need to register Subscriber Identity Module (SIM) Cards;

WHEREAS, foregoing premises considered and after due deliberation on the matter, the 8th City Council deemed it necessary to pass a resolution enjoining all barangay council of the 64 barangays in the City of Sorsogon to conduct information dissemination campaign and provide assistance in the registration of Subscriber Identity Module (SIM) cards of barangay residents in consonance with Republic Act No. 11934 otherwise known as “Subscriber Identity Module (SIM) Registration Act”;

NOW THEREFORE, on motion of **Hon. Jo Abegail C. Dioneda**, duly seconded by **Hon. Bessie C. Diaz**, resolved as it is hereby resolved to enjoin all barangay council of the 64 barangays in the City of Sorsogon to conduct information dissemination campaign and provide assistance in the registration of Subscriber Identity Module (SIM) cards of barangay residents in consonance with Republic Act No. 11934 otherwise known as “Subscriber Identity Module (SIM) Registration Act”;

RESOLVED FURTHER, that this resolution be furnished to the 64 barangays of the City of Sorsogon for their information and appropriate action.
