RESOLUTION DECLARING VALID BARANGAY ORDINANCE NO. 02, SERIES OF 2023 FROM THE BARANGAY COUNCIL OF PIOT, WEST DISTRICT, SORSOGON CITY ENTITLED “ORDINANSANG NAGTATATAG NG PROGRAMANG HALINA’T MAGTANIM NG PRUTAS AT GULAY (HAPAG) SA BARANGAY, NAGTATADHANA NG PATULOY NA OPERASYON NITO AT PARA SA IBA PANG MAY KAUGNAYANG LAYUNIN”.

WHEREAS, Barangay Ordinance No. 002, Series of 2023 from the Barangay Council of Piot, West District, Sorsogon City entitled, “ORDINANSANG NAGTATATAG NG PROGRAMANG HALINA’T MAGTANIM NG PRUTAS AT GULAY (HAPAG) SA BARANGAY, NAGTATADHANA NG PATULOY NA OPERASYON NITO AT PARA SA IBA PANG MAY KAUGNAYANG LAYUNIN” was among the items deliberated upon by the 8th City Council during the February 14, 2023 Regular Session;

virtue of Chapter 4, Section 391 of Republic Act 7160 otherwise known as the Local Government Code of 1991.

WHEREAS, the Sangguniang Panlungsod finds the barangay ordinance intra vires as mandated by the Local Government Code of 1991;

WHEREAS, foregoing premise considered and after due deliberation on the matter, the 8th City Council deemed it necessary to pass a resolution declaring valid Barangay Ordinance No. 002, Series of 2023 from the Barangay Council of Piot, West District, Sorsogon City entitled, **“ORDINANSANG NAGTATATAG NG PROGRAMANG HALINA’T MAGTANIM NG PRUTAS AT GULAY (HAPAG) SA BARANGAY, NAGTATADHANA NG PATULOY NA OPERASYON NITO AT PARA SA IBA PANG MAY KAUGNAYANG LAYUNIN”**;
