**RESOLUTION DECLARING VALID BARANGAY ORDINANCE NO. 03, SERIES OF 2023 FROM THE BARANGAY COUNCIL OF PIOT, WEST DISTRICT, SORSOGON CITY ENTITLED "AN ORDINANCE LOCALIZING THE APPLICABILITY OF THE SAFE SPACES ACT IN ORDER TO FACILITATE IMPLEMENTATION AND ENFORCEMENT THEREOF WITHIN THE TERRITORIAL JURISDICTION OF BARANGAY PIOT, WEST DISTRICT, SORSOGON CITY".**

**WHEREAS**, Barangay Ordinance No. 003, Series of 2023 from the Barangay Council of Piot, West District, Sorsogon City entitled, "AN ORDINANCE LOCALIZING THE APPLICABILITY OF THE SAFE SPACES ACT IN ORDER TO FACILITATE IMPLEMENTATION AND ENFORCEMENT THEREOF WITHIN THE TERRITORIAL JURISDICTION OF BARANGAY PIOT, WEST DISTRICT, SORSOGON CITY" was among the items deliberated upon by the 8<sup>th</sup> City Council during the February 14, 2023 Regular Session;

**WHEREAS**, cursory reading of the submitted barangay ordinance reveals that the said barangay ordinance is within the ambits of the powers conferred to the barangay council by virtue of Chapter 4, Section 391 of Republic Act 7160 otherwise known as the Local Government Code of 1991.

**WHEREAS**, the Sangguniang Panlungsod finds the barangay ordinance intra vires as mandated by the Local Government Code of 1991;


**WHEREAS**, foregoing premise considered and after due deliberation on the matter, the 8<sup>th</sup> City Council deemed it necessary to pass a resolution declaring valid Barangay Ordinance No. 002, Series of 2023 from the Barangay Council of Piot, West District, Sorsogon City entitled **“AN ORDINANCE LOCALIZING THE APPLICABILITY OF THE SAFE SPACES ACT IN ORDER TO FACILITATE IMPLEMENTATION AND ENFORCEMENT THEREOF WITHIN THE TERRITORIAL JURISDICTION OF BARANGAY PIOT, WEST DISTRICT, SORSOGON CITY”**;
