RESOLUTION ADOPTING AND APPROVING THE CITY DISASTER RISK REDUCTION AND MANAGEMENT COUNCIL (CDRRMC) RESOLUTION NO. 02, SERIES OF 2023 ENTITLED “RESOLUTION APPROVING THE REPROGRAMMING/ REALIGNMENT OF CONTINUING 2021 ACTIVITY AND BUDGET UNDER THE LOCAL DISASTER RISK REDUCTION AND MANAGEMENT FUND FOR CY 2023 AMOUNTING TO SIX MILLION SEVENTY-NINE THOUSAND SEVEN HUNDRED SEVENTY-TWO AND 15/100 PESOS (P6,079, 772.15)

WHEREAS, on February 28, 2023, the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City wrote a letter addressed to the Honorable Members of the Sangguniang Panlungsod thru Hon. Mark Eric C. Dioneda, City Vice Mayor, Sorsogon City respectfully requesting among others, adoption and approval of City Disaster Risk Reduction And Management Council (CDRRMC) Resolution No. 02, Series of 2023 entitled “Resolution Approving the Reprogramming/ Realignment of continuing 2021 activity and budget under the Local Disaster Risk Reduction and

Management Fund for CY 2023 amounting to Six Million Seventy-Nine Thousand Seven Hundred seventy-two and 15/100 pesos (P6,079, 772.15).”

WHEREAS, under Section 5 of Rule 5 of the IRR of Republic Act No. 10121, Local DRRM Councils are mandated to conduct meetings once every three months with the Local DRR Office serving as the Secretariat;

WHEREAS, in the Local DRRM Plan for CY 2023, the procurement of IT for CBMS and Backhoe were not sufficient, hence additional budget must be allocated;

WHEREAS, among the documents attached to the aforementioned letter of the Hon. MA. Ester E. Hamor was the CDRRMC Resolution No. 03-2022 for perusal of the 8th City Council;

WHEREAS, foregoing premise considered and after due deliberation on the matter, the 8th City Council deemed it necessary to pass a resolution adopting and approving City Disaster Risk Reduction and Management Council (CDRRMC) Resolution No. 02, Series of 2023 entitled “Resolution Approving the Reprogramming/ Realignment of continuing 2021 activity and budget under the Local Disaster Risk Reduction and Management Fund for CY 2023 amounting to Six Million Seventy-Nine Thousand Seven Hundred seventy-two and 15/100 pesos (P6,079, 772.15).”
