Resolution No. 136, Series of 2023

(Unanimously Proposed)

RESOLUTION ADOPTING THE CITY DISASTER RISK REDUCTION AND MANAGEMENT COUNCIL (CDRRMC) RESOLUTION NO. 01- 2023 ENTITLED “RESOLUTION APPROVING AND ADOPTING THE DISASTER RISK REDUCTION AND MANAGEMENT PLAN (LDRRMP) FOR SPECIAL TRUST FUND BALANCES FROM LDRRMF CYS 2018, 2020, 2021 AND 2022 FOR CY 2023 WITH THE TOTAL AMOUNT OF THIRTY TWO MILLION FOUR HUNDRED SIXTY THOUSAND SIX HUNDRED FIFTY FOUR AND 4/100 (P 32,460, 654.4) PESOS”

WHEREAS, on February 28, 2023, the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City wrote a letter addressed to the Honorable Members of the Sangguniang Panlungsod thru Hon. Mark Eric C. Dioneda, City Vice Mayor, Sorsogon City respectfully requesting among others, adoption and approval of City Disaster Risk Reduction And Management Council (CDRRMC) Resolution No. 01-2023 entitled “Resolution Approving And Adopting The Disaster Risk Reduction And Management Plan (LDRRMP) For Special Trust Fund Balances From LDRRMF CYS 2018, 2020, 2021 And 2022 For Cy 2023 With The Total Amount Of Thirty Two

Million Four Hundred Sixty Thousand Six Hundred Fifty Four And 4/100 (P 32,460, 654.4) Pesos”

WHEREAS, Section 2 (a) of Republic Act 10121, otherwise known as the “Philippine Disaster Risk Reduction and Management Act of 2010”, proclaims that it shall be the policy of the state to uphold the people’s constitutional rights to life and property by addressing the root causes of vulnerabilities to disasters, strengthening the country’s institutional capacity for disaster risk reduction and management and building the resilience of local communities to disasters including climate change impacts”;

WHEREAS, Section 6.4 of the same JMC states that “the unexpended LDRRMF shall accrue to a special trust fund solely for the purpose of supporting disaster risk reduction and management activities of the Local Disaster Risk Reduction Management Council (LDRRMC) for the next five (5) years”;

WHEREAS, Section 6.5 of NDRRMC, DBM and DILG Joint Memorandum Circular No. 2013-1 dated March 25, 2013, states that “the unexpended balances of the LDRRMF may be released and utilized for new expenditure items upon submission of the revised AIP as approved by the Local Sanggunian and Local Chief Executive upon recommendation of the LDRRMC in accordance with the approved LDRRMP;”

WHEREAS, among the documents attached to the aforementioned letter of the Hon. Ma. Ester E. Hamor was the CDRRMC Resolution No. 01-2023 for perusal of the 8th City Council;

WHEREAS, foregoing premise considered and after due deliberation on the matter, the 8th City Council deemed it necessary to pass a resolution adopting the City Disaster Risk Reduction and Management Council (CDRRMC) Resolution No. 01-2023 entitled “Resolution Approving And Adopting The Disaster Risk Reduction And Management Plan (LDRRMP) For Special Trust Fund Balances From LDRRMF CYS 2018, 2020, 2021 And 2022 For Cy 2023 With The Total Amount Of Thirty Two Million Four Hundred Sixty Thousand Six Hundred Fifty Four And 4/100 (P 32,460, 654.4) Pesos”

NOW THEREFORE, on incidental motion of **Hon. Nestor J. Baldon**, duly seconded by the **Hon. Jo Abegail C. Dioneda**, resolve as it is hereby resolved to adopt the City Disaster Risk Reduction and Management Council (CDRRMC) Resolution No. 08, Series of 2022 entitled “Resolution approving and adopting the Local Disaster Risk Reduction and Management Plan (LDRRMP) and Local Risk Reduction Management Fund Investment Plan for Cy 2023”;
