RESOLUTION INTERPOSING NO OBJECTION ON THE ESTABLISHMENT OF A GASOLINE STATION AND MOTOR LODGE AT LOT 2, MAHARLIKA HIGHWAY, BARANGAY GUINLAJON, WEST DISTRICT, SORSOGON CITY

WHEREAS, on February 09, 2023, Mr. Joseph H. Yap, III wrote a letter addressed to the Hon. Mark Eric C. Dioneda, City Vice Mayor respectfully requesting for the passage of a resolution interposing no objection on the establishment of a Gasoline Station and Motor Lodge at Lot 2, Maharlika Highway, Barangay Guinlajon, West District, Sorsogon City;

WHEREAS, aforementioned letter request was among the items deliberated upon by the 8th City Council during the February 14, 2023 Regular Session and was jointly referred to the Committee on Trade, Commerce and Industry, Committee on Peace, Public Order and Safety and Committee on Transportation and Public Utilities.

WHEREAS, on February 28, 2023, a Joint Committee Hearing was conducted for this purpose duly attended by technical persons from various departments of the City of Sorsogon taking into consideration the pertinent documents submitted by the applicant;

WHEREAS, foregoing premise considered and after adoption and approval of the Joint Committee Report, the 8th City Council deemed it necessary to pass a resolution interposing no objection on the establishment of a Gasoline Station and Motor Lodge at Lot 2, Maharlika Highway, Barangay Guinlajon, West District, Sorsogon City;

NOW THEREFORE, on incidental motion of **Hon. Peter Joseph J. Ravanilla** duly seconded by **Hon. Danilo A. Deladia**, resolve as it is hereby resolved to interpose no objection on the establishment of a Gasoline Station and Motor Lodge at Lot 2, Maharlika Highway, Barangay Guinlajon, West District, Sorsogon City;
