RESOLUTION FAVORABLY ENDORSING TO MAJOR GENERAL ANTONIO N. GARDIOLA (RET.), REGIONAL DIRECTOR, LAND TRANSPORTATION FRANCHISING REGULATORY BOARD (LTFRB) THE INTENT OF JEEPNEY OPERATORS AND DRIVERS ASSOCIATION TRANSPORT SERVICE COOPERATIVE TO APPLY FOR SORSOGON-CUMADCAD CASTILLA ROUTE.

WHEREAS, the Jeepeney Operators and Drivers Association Transport Service Cooperative is one of the oldest transport group operating in Sorsogon for almost five (5) decades;

Whereas, this transport group appeared before the 8th City Council during the February 28, 2023 Regular Session and expressed their present predicament;

WHEREAS, the 8th City Council understands that the Land Transportation Franchising Regulatory Board has the sole authority to issue franchises on jeepneys, however, following the provisions of Section 16 (General Welfare Clause) of Republic Act 7160, otherwise known as the Local Government Code of 1991 and especially when the

matter was brought and discussed before the 8^{th} City Council in a regular session, the august body has the responsibility to exhaust possible remedies, thus this resolution;

WHEREAS, in addition thereto, the Chairman of the Committee on Transportation and Public Utilities of the 8th City Council of Sorsogon have already made some preliminary discussions with the Hon. Ryan Dioneda, Chairman of the Committee on transportation of the Sangguniang Panlalawigan in order to extend help and resolve the matter accordingly;

WHEREAS, foregoing premise considered and after deliberation on the matter, the 8th City Council deemed it necessary to pass a resolution favorably endorsing to Major General Antonio N. Gardiola (Ret.), Regional Director, Land transportation Franchising Regulatory Board (LTFRB) the intent of Jeepney Operators and Drivers Association Transport Service Cooperative to apply for Sorsogon-Cumadcad Castilla Route;

NOW THEREFORE, on motion of City Councilor Danilo A. Deladia, duly seconded by City Councilor Nestor J. Baldon, resolve as it is hereby resolved to favorably endorse to Major General Antonio N. Gardiola (Ret.), Regional Director, Land transportation Franchising Regulatory Board (LTFRB) the intent of Jeepney Operators and Drivers Association Transport Service Cooperative to apply for Sorsogon-Cumadcad Castilla Route;
