RESOLUTION RESPECTFULLY REQUESTING THE HON. MA. ESTER E. HAMOR, CITY MAYOR, SORSOGON CITY THRU THE CITY ENGINEERING OFFICE TO ALLOCATE FUNDS FOR THE REHABILITATION OF SORSOGON CITY TRICYCLE TERMINAL LOCATED AT THE BASEMENT OF SAVE MORE, MAGSAYSAY STREET, SORSOGON CITY.

WHEREAS, it is the policy of the City Government of Sorsogon to sustainably develop and maintain through rehabilitation the communal facilities such as the Sorsogon City Tricycle Terminal;

WHEREAS, an orderly and organized City Tricycle Terminal is a vestige of efficiency in managing the daily transportation affairs of tricycle drivers as well as the passengers traversing within this City;

WHEREAS, the City Government Program for sanitation which being implemented within the city terminal shall orient the conscious awareness of City constituents and the passengers on vital matters of health and environment;

WHEREAS, unclogging the roads and alleys and maintaining orderly city traffic being the *raison d'être* for the establishment and maintenance of the Sorsogon City Tricycle Terminal;

WHEREAS, the allocation of fund for the maintenance and rehabilitation of the City Tricycle Terminal denotes an agenda for the interest and sake of tricycle drivers and the commuting public.

WHEREAS, the rehabilitation of the City Tricycle Terminal is a priority project for sanitation and beautification based upon the Sorsogon City Government agenda and paradigm of economic growth, thus rehabilitation of the City Tricycle Terminal denotes economic progress as a consequence;

WHEREAS, foregoing premises considered and after due deliberation on the matter, the 8th City Council deemed it necessary to pass a resolution respectfully requesting the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City through the City Engineering Office to allocate funds for the rehabilitation of Sorsogon City Tricycle Terminal located at the basement of Save More, Magsaysay Street, Sorsogon City;
