RESOLUTION RESPECTFULLY REQUESTING THE HON. MA. ESTER E. HAMOR, CITY MAYOR, SORSOGON CITY THROUGH MR. ARNEL ANCHINGES, SK3 HEAD TO CONSIDER THE INCLUSION OF SORSOGON INTEGRATED TERMINAL EXCHANGE (SITEX) TO BARANGAY SALVACION, WEST DISTRICT ROUTE IN THE LOCAL PUBLIC TRANSPORT ROUTE PLAN (LPTRP) FOR PUBLIC UTILITY VEHICLES (PUV) PLYING WITHIN THE TERRITORIAL JURISDICTION OF THE CITY OF SORSOGON.

WHEREAS, among the commitment that the City Government shall endeavor during the Executive-Legislative Agenda held sometime in September of 2022 in Tagaytay City is the preparation of the Local Public Transport Route Plan;

WHEREAS, in consonance thereof, the Local Chief Executive issued an Executive Order creating a Technical Working Group composed of members of the City Council and technical persons from the executive department;

WHEREAS, among the issues and concerns brought before the 8th City Council by some members of the transport group is their appeal to include the aforementioned subject route in the Local Public Transport Route Plan of the City Government of Sorsogon;

WHEREAS, as a matter of principle, the 8th City Council recognizes the plight of our transport sector specially when the present circumstances they experience appears to be adverse and unfavorable economically;

WHEREAS, the herein route inclusion denotes sound organization and peaceful co-existence by and between and among drivers and operators of various transport associations in the city;

WHEREAS, for reasons of beneficence and economic necessity, the inclusion of route from SITEX to Salvacion West District, vice versa, in the Local Public Transport Route Plan is a sound judgement on behalf of the poor families of drivers and operators;

WHEREAS, foregoing premise considered and after due deliberation on the matter, the 8th City Council deemed it necessary to pass a resolution respectfully requesting the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City through Mr. Arnel Anchinges, SK3 Head to consider the inclusion of Sorsogon Integrated Terminal Exchange (SITEX) to Barangay Salvacion, West District Route in the Local Public Transport Route Plan (LPTRP) for Public Utility Vehicles (PUV) plying within the territorial jurisdiction of the City of Sorsogon;
