RESOLUTION DECLARING VALID BARANGAY ORDINANCE NO. 003-2023 FROM THE BARANGAY COUNCIL OF BARANGAY TALISAY, WEST DISTRICT, SORSOGON CITY ENTITLED "AN ORDINANCE AUTHORIZING THE CITY/MUNICIPALITY OF SORSOGON TO ISSUE BARANGAY CLEARANCE AND COLLECT CORRESPONDING BARANGAY CLEARANCE FEE IN THE APPLICATION FOR ANY BUSINESS RELATED TRANSACTIONS SUBJECT TO THE REMITTANCE OF THE AFORESAID FEES TO THE BARANGAY AND THE CONDITIONS HEREUNDER.

WHEREAS, among the items deliberated upon by the 8th City Council during the March 14, 2023 regular session was the aforementioned barangay ordinance from the Barangay Council of Barangay Talisay, West District, Sorsogon City;

WHEREAS, said barangay ordinance appears to be mere compliance of the Barangay Council of Memorandum Circular No. 2019-177 issued by the Department of the Interior and Local

Government (DILG) in relation to the Guidelines in the Issuance of Barangay Clearance in the Permitting Processes of Cities and Municipalities;

WHEREAS, other provisions therein stated also complies with the very intent and purpose of the herein mentioned Memorandum Circular from the Department of the Interior and Local Government (DILG);
