## *Resolution No. 155, Series of 2023*

**RESOLUTION DECLARING VALID BARANGAY ORDINANCE NO. 01 SERIES OF 2023 FROM THE BARANGAY COUNCIL OF BARANGAY TICOL, WEST DISTRICT, SORSOGON CITY ENTITLED "AN ORDINANCE ESTABLISHING THE HALINA'T MAGTANIM NG PRUTAS AT GULAY (HAPAG) SA BARANGAY PROVIDING FOR ITS SUSTAINED OPERATION AND FOR OTHER PURPOSES.**

**WHEREAS**, Barangay Ordinance No. 01, Series of 2023 from the Barangay Council of Ticol, West District, Sorsogon City entitled "**AN ORDINANCE ESTABLISHING THE HALINA'T MAGTANIM NG PRUTAS AT GULAY (HAPAG) SA BARANGAY PROVIDING FOR ITS SUSTAINED OPERATION AND FOR OTHER PURPOSES**", was among the items deliberated upon by the 8<sup>th</sup> City Council during the February 28, 2023 Regular Session of the 8<sup>th</sup> City Council;

**WHEREAS**, cursory reading of the submitted barangay ordinance reveals that the said barangay ordinance is within the ambits of the powers conferred to the barangay council by virtue of relevant provisions of Republic Act 7160 otherwise known as the Local Government Code of 1991 and as contained in Committee Report No. 044, series of 2023 of the Committee on Rules duly approved and adopted by the 8<sup>th</sup> City Council;

**WHEREAS**, the Sangguniang Panlungsod finds the barangay ordinance intra vires as mandated by the Local Government Code of 1991;

**WHEREAS**, foregoing premise considered and after due deliberation on the matter, the 8<sup>th</sup> City Council deemed it necessary to pass a resolution declaring valid aforementioned barangay ordinance entitled **“AN ORDINANCE ESTABLISHING THE HALINA’T MAGTANIM NG PRUTAS AT GULAY (HAPAG) SA BARANGAY PROVIDING FOR ITS SUSTAINED OPERATION AND FOR OTHER PURPOSES”**;

**NOW THEREFORE**, on incidental motion of **Hon. Angelu Magda P. Ravanilla** duly seconded by **Hon. Bessie Diaz**, resolve as it is hereby resolved to declare valid aforementioned barangay ordinance entitled **“AN ORDINANCE ESTABLISHING THE HALINA’T MAGTANIM NG PRUTAS AT GULAY (HAPAG) SA BARANGAY PROVIDING FOR ITS SUSTAINED OPERATION AND FOR OTHER PURPOSES”**;
