RESOLUTION ENDORSING THE REQUEST OF THE SORSOGON CITY PHILIPPINE NATIONAL POLICE (PNP) TO CPNP PGEN. RODOLFO A. AZURIN JR. FOR TWO (2) UNITS OF PATROL JEEP TOYOTA HI-LUX DOUBLE CAB FOR USE FOR PROGRAMS ON PEACE AND SECURITY IN THE CITY OF SORSOGON.

WHEREAS, among the items deliberated during the March 21, 2023 Regular Session of the 8th City Council was the Transmittal No. 16, Series of 2023 from the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City dated March 14, 2023 addressed to Hon. Mark Eric C. Dioneda, City Vice Mayor, Sorsogon City thru Mr. Rovon E. Domasian, SP Secretary relative to the request for a resolution endorsing the request of the Sorsogon City Philippine National Police (PNP) to CPNP PGEN Rodolfo A. Azurin, Jr. for two (2) units

of patrol jeep toyota hi-lux double cab for use for programs on peace and security in the City of Sorsogon;

WHEREAS, the Sorsogon City PNP is one of the strongest partners in the implementation of programs relative to the peace and order of the community thus LGU provided the local police force with patrol cars that they are currently using for monitoring and response;

WHEREAS, LGU Sorsogon City understands that Sorsogon City PNP requires a sizeable number of vehicles for especially for their operations, considering that the City of Sorsogon is comprised of Sixty Four (64) barangays and as such LGU Sorsogon City highly supports their efforts to acquire additional vehicles which can be used for the local programs on security;

WHEREAS, attached to the City Mayor's letter is a copy of the letter of P/LtCol Jeric Don P. Sadia, Chief of Police, Sorsogon City Police Station, for further perusal of the 8th City Council;

Duka** resolve as it is hereby resolved to endorse the request of the Sorsogon City PNP to CPNP PGEN Rodolfo A. Azurin, Jr. for two (2) units of Patrol Jeep Toyota Hi-Lux double cab intended for use for programs on peace and security in the City of Sorsogon.
