## Resolution No. 184, Series of 2023

RESOLUTION DECLARING VALID BARANGAY ORDINANCES FROM THE BARANGAY COUNCIL OF BARANGAY MACABOG, BUENAVISTA, SALVACION, GUINLAJON, BARAYONG, BITAN-O/DALIPAY, RIZAL, BULABOG, PANLAYAAN, BASUD, PEÑAFRANCIA, TALISAY AND BUCALBUCALAN, ALL OF WEST DISTRICT, SORSOGON CITY ENTITLED "AN ORDINANCE ESTABLISHING THE HALINA'T MAGTANIM NG PRUTAS AT GULAY (HAPAG) SA BARANGAY PROVIDING FOR ITS SUSTAINED OPERATION AND FOR OTHER PURPOSES.

WHEREAS, aforementioned Barangay Ordinances from the Barangay Councils of West District entitled "AN ORDINANCE ESTABLISHING THE HALINA'T MAGTANIM NG PRUTAS AT GULAY (HAPAG) SA BARANGAY PROVIDING FOR ITS SUSTAINED OPERATION

AND FOR OTHER PURPOSES", was among the items deliberated upon under Committee Report No. 048, Series of 2023 by the 8th City Council during the March 21, 2023 Regular Session of the 8th City Council:

WHEREAS, cursory reading of the submitted barangay ordinances reveals that the same is within the ambits of the powers conferred to the barangay council by virtue of relevant provisions of Republic Act 7160 otherwise known as the Local Government Code of 1991 and as contained in Committee Report No. 044, series of 2023 of the Committee on Rules duly approved and adopted by the 8th City Council;

WHEREAS, the Sangguniang Panlungsod finds the barangay ordinances intra vires as mandated by the Local Government Code of 1991;

WHEREAS, foregoing premise considered and after due deliberation on the matter, the 8<sup>th</sup> City Council deemed it necessary to pass a resolution declaring valid from the Barangay Council of Barangay Macabog, Buenavista, Salvacion, Guinlajon, Barayong, Bitan-O/Dalipay, Rizal, Bulabog, Panlayaan, Basud, Peñafrancia, Talisay and Bucalbucalan, All of West District, Sorsogon City entitled "An Ordinance establishing the Halina't Magtanim ng Prutas at Gulay (Hapag) sa Barangay Providing for its Sustained Operation and for other Purposes;
